1. In the Registration Document the subsection "I. Statutory Auditors" of section "C. Information about Goldman, Sachs & Co. Wertpapier GmbH" on page 8 shall be replaced as follows:

#### "I. STATUTORY AUDITORS

The statutory auditor for the unconsolidated financial statements of GSW as of and for the fiscal year ended 31 December 2021 was MAZARS GmbH & Co. KG Wirtschaftsprüfungsgesellschaft Steuerberatungsgesellschaft, Theodor-Stern-Kai 1, 60596 Frankfurt am Main, Germany, ("MAZARS GmbH & Co. KG"). MAZARS GmbH & Co. KG is a member of the German Chamber of Public Accountants (*Wirtschaftsprüferkammer*), a public body (*Körperschaft des öffentlichen Rechts*), Raucherstraße 26, 10787 Berlin.

The statutory auditor for the unconsolidated financial statements of GSW as of and for the fiscal year ended 31 December 2020 was PricewaterhouseCoopers GmbH Wirtschaftsprüfungsgesellschaft ("**PwC GmbH**"), Friedrich-Ebert-Anlage 35 – 37, 60327 Frankfurt am Main. PwC GmbH is a member of the German Chamber of Public Accountants (*Wirtschaftsprüferkammer*), a public body (*Körperschaft des öffentlichen Rechts*), Raucherstraße 26, 10787 Berlin."

2. In the Registration Document the subsection "V. Trend information" of section "C. Information about Goldman, Sachs & Co. Wertpapier GmbH" on pages 10 et seq shall be replaced as follows:

#### "V. TREND INFORMATION

Since the date of its last audited financial statements (31 December 2021) there has been no material adverse change in the prospects of GSW.

Since the end of the last financial period for which financial information has been published (31 December 2021), there has been no significant change in the financial performance of GSW.

The issuance activity is expected to decrease significantly in 2022 given a majority of the securities issuance business has been migrated to GSBE. Consequently, profits are expected to decrease though the Company's profitability is assured.

The Russian invasion of Ukraine in February 2022 has led to significant disruption in financial markets and increased uncertainty in the business environment in which the Company operates. The future impact of the war on the company's operational and financial performance remains difficult to predict at this time."

PwC GmbH audited the unconsolidated financial statements of GSW as of and for the fiscal year ended 31 December 2020 and issued an unqualified auditor's report (*Bestätigungsvermerk*).

#### 4. Legal and arbitration proceedings

During the last 12 months, there were no governmental, legal or arbitration proceedings which may have, or have had in the recent past, significant effects on GSW's financial position or profitability, and none of them were settled during the last 12 months, respectively. Neither are there any such proceedings pending or threatened of which GSW is aware.

## 5. Significant change in GSW's financial position

Since the end of the last financial period for which audited financial information have been published (31 December 2021) no significant change in GSW's financial position has occurred.

### 6. Statements in relation to prospects, financial performance or financial position
