Rights of withdrawal

In accordance with Article 13 paragraph 2 of the Luxembourg Law, investors who have already agreed to purchase or subscribe for the securities before this Prospectus Supplement is published have the right exercisable until August 27, 2018, which is two working days after the publication of this Prospectus Supplement, to withdraw their acceptances.
