The base prospectus consisting of separate documents for Securities (issued in the form of Certificates, Notes or Warrants) dated 10 February 2021 (the "**Base Prospectus**") (as supplemented) is composed of the Registration Document for retail non-equity securities dated 10 June 2021 of Goldman, Sachs & Co. Wertpapier GmbH (the "**Registration Document**") and the Securities Note for Securities (issued in the form of Certificates, Notes or Warrants) dated 10 February 2021 of Goldman, Sachs & Co. Wertpapier GmbH (the "**Securities Note**"). The significant new factor resulting in this supplement (the "**Supplement**") is the publication of the unaudited interim financial statements of Goldman, Sachs & Co. Wertpapier GmbH for the period ended 30 June 2021 for the first half of the financial year 2021 on 27 September 2021.

Due to this Supplement the information contained in the Registration Document which is part of the Base Prospectus shall be supplemented as follows:

1. In the Registration Document the second paragraph of subsection "V. Trend information" of section "C. Information about Goldman, Sachs & Co. Wertpapier GmbH" on page 10 shall be replaced as follows:

"Since the end of the last financial period for which financial information has been published (30 June 2021), there has been no significant change in the financial performance of GSW."

4. Auditing of historical financial information

PwC GmbH audited the unconsolidated financial statements of GSW as of and for the fiscal years ended 31 December 2020 and 31 December 2019, and issued in each case an unqualified auditor's report (*Bestätigungsvermerk*).

The financial information of GSW for the first half of the financial year 2021 has not been audited.

5. Legal and arbitration proceedings

During the last 12 months, there were no governmental, legal or arbitration proceedings which may have, or have had in the recent past, significant effects on GSW's financial position or profitability, and none of them were settled during the last 12 months, respectively. Neither are there any such proceedings pending or threatened of which GSW is aware.

6. Significant change in GSW's financial position

Since the end of the last financial period for which interim financial information has been published (30 June 2021) no significant change in GSW's financial position has occurred.

7. Statements in relation to prospects, financial performance or financial position
