The significant new factors resulting in this supplement (the "**Supplement**") to the Base Prospectus are (i) the publication of the Base Prospectus Euro Medium-Term Notes, Series F of The Goldman Sachs Group, Inc. dated 15 April 2022 (the "**GSG Base Prospectus**") on 15 April 2022 and (ii) the publication of the Report on Form 8-K dated 14 April 2022 (the "**Form 8-K 14 April 2022**") on 14 April 2022 which has been filed with the US Securities and Exchange Commission (the "**SEC**") by the Guarantor on 14 April 2022 and has also been filed with the Commission de Surveillance du Secteur Financier ("**CSSF**") in Luxembourg in connection with the GSG Base Prospectus.

Due to this Supplement the information contained in the Base Prospectus (if applicable: in the form as lastly supplemented) shall be supplemented as follows:

*1. In the Base Prospectus the paragraph in subsection "3. Risk factors in connection with the Guarantor" of section "II. Risk factors" on page 11 shall be replaced as follows:*
