

OFFICIAL RULES – #1MPETSTOGETHERPROMO SWEEPSTAKES

These are the Official Rules for the #1MPetsTogetherPromo Sweepstakes (“Sweepstakes”). The Sweepstakes is sponsored by Nationwide Mutual Insurance Company (“Nationwide”), One Nationwide Plaza, Columbus, Ohio 43215.

ELIGIBILITY

DRAWING
