

Nationwide® 2021 Holiday E-card Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ELIGIBILITY: Subject to exceptions noted below, Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, unless excluded below, and are 18 years of age or older at the time of entry.
