

OFFICIAL RULES – Nationwide® 2022 Munch Mania E-card Sweepstakes

These are the Official Rules of the Nationwide Pet 2022 Munch Mania E-card Sweepstakes (“Sweepstakes”). The Sweepstakes is sponsored by Nationwide Mutual Insurance Company (“Nationwide”), One Nationwide Plaza, BRE-05, Columbus, Ohio 43215.

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. MAKING A PURCHASE WILL NOT INCREASE THE ODDS OF WINNING.

ELIGIBILITY

This Sweepstakes is open to legal residents of the fifty United States and the District of Columbia, except where prohibited and as noted below, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. **No purchase is necessary. Not available to residents of Georgia, Maine, Washington, and Rhode Island.**

Drawing will be held no later than 04/09/2022.

To enter complete one of the following options:

1. Visit petinsurance.com/referral and select the Game Day e-card by clicking the e-card. Fill out the form by entering the referred name (your friend), your friend's email address, your name, your email address and your

state of residence. Send the e-card by clicking the Send button.

2. Visit petinsurance.com/referral and click the “share on Facebook” button below the Game Day e-card. Fill out the form by entering your e-mail address and state of residence. Share the e-card on your Facebook wall by clicking the Share button.

3. **ALTERNATE METHOD OF ENTRY:** You may enter by filling out an online entry form found at www.petinsurance.com/munchmaniaaltentry. You must provide a valid email address and state of residency. No purchase necessary. Limit one entry per person per day.

Each unique e-card send, shared Facebook post, or alternate entry enters you for a chance to win. All entries in the Prize drawing have an equal chance of winning. Odds of winning a prize depend on the number of eligible entries received during each Sweepstakes Period.

Entry constitutes consent to participate in a Sweepstakes and for Nationwide to obtain, use, and transfer the entrant's name, address and other details for Sweepstakes administration purposes. DRAWING

winners will become ineligible to become future Prize winners.

The Prize winner can select and designate a person of their choice to be gifted the same Prize ("Gifted Prize") The Prize winners and Gifted Prize winners will receive gift cards in the form of an emailed e-gift card or physical gift card sent via standard mail in the prize box.
