



OFFICIAL RULES – Nationwide Pet She Snoots, She Scores Sweepstakes

These are the Official Rules for the She Snoots, She Scores Sweepstakes ("Sweepstakes"). The Sweepstakes is sponsored by Nationwide Mutual Insurance Company ("Nationwide"), One Nationwide Plaza, Columbus, Ohio 43215.

No purchase is necessary to enter or win. Making a purchase will not increase the odds of winning.

1. Eligibility.

- 1.1. Open to Legal Residents.** The Promotion is open to legal residents of the fifty United States and the District of Columbia, excluding the states of Georgia, Kansas, Kentucky, Maine, Minnesota, New Hampshire, and Washington, and except where excluded and prohibited by law, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. No purchase is necessary.
- 1.2. 2. How to Enter.

2.1. Promotion Period.

The Sweepstakes will run from August 1, 2022 at 12:01 am PST, to August 31, 2022 at 11:59 pm PST ("Promotion Period").

2.2. Entry.

One (1) Grand Prize and five (5) Runner-Up Prizes will be selected via a random drawing at the end of the Promotion Period. To enter, you must be eligible to enter and complete only one of the following four options:

You must provide your email address, select a pet insurance plan, and click "Next" to complete the quote process.
2. **Follow the link in the promotional email provided by your participating insurance agent** during the Promotion Period and complete a quote for pet insurance. You must provide your email address, select a pet insurance plan, and click "Next" to complete the quote process.
3. **Follow the link in the promotional email provided by your participating veterinary practice** during the Promotion Period to access the sweepstakes landing page and complete a quote for pet insurance. You must provide your email address, select a pet insurance plan, and click "Next" to complete the quote process.
4. **Log in to your Nationwide pet insurance member portal at <https://my.petinsurance.com>** during the Promotion Period and complete a quote on pet insurance for one of your own pets who isn't currently insured by Nationwide, or one that you'd like to get in the future. You must provide your email address, select a pet insurance plan, and click "Next" to complete the quote process. While you are free to get quotes for any pets you may have in



the future, please note that you must actually own the pet before enrolling him or her in a pet insurance policy.

By confirming your email address, you are agreeing to these Official Rules.

2.3. Restrictions.

Limit one (1) entry per person per day during the Promotion Period. Nationwide will disqualify anyone found to have submitted multiple entries. In addition, Nationwide will not consider ineligible, illegible, or incomplete submissions.

2.4. Conditions.

Entrants agree to be bound by the Official Rules and the decisions of Nationwide, which are final and binding on all matters relating to the Sweepstakes. Nationwide is not responsible for any typographical or other errors in printing the offer, administration of the Sweepstakes or the announcement of the prizes, or for lost, late, misdirected, damaged, incomplete or illegal entries.

2.5. Participant's Consent.

Entry constitutes consent to participate in Promotions and for Nationwide to obtain, use, and transfer the entrant's photo for Promotion administration purposes. Each Runner-Up Prize Winner chosen will receive one (1) sports bag of soccer swag and one (1) \$100 gift card. Approximate Runner-Up Prize: \$333. Total ARV: \$3,915.

6.2. No Responsibility.
