Massachusetts State Lottery Commission's Scan To Enter - Super Summer Promotion

Official Rules

**1. GENERAL:** By participating in the Massachusetts State Lottery's Scan to Enter Super Summer Promotion (the "Promotion"), which is sponsored by the Massachusetts State Lottery Commission (the "Lottery"), located at 150 Mt Vernon Street, Dorchester, MA 02125, the entrant acknowledges and agrees to all of these Official Rules. The purpose of this promotion is to encourage and promote the use of the Lottery's mobile app to scan and enter a drawing and receive payment for those who are selected to win a prize through the random drawing. Eligible entrants are Lottery players who have created a valid account on the Lottery mobile app or a MA Lottery Player Account and who scan a non-winning or manually enter a non-winning ticket during the entry period as provided herein. All times in the Promotion refer to Eastern Time (ET). By participating in the Promotion, entrants agree to be bound by the Official Rules and by all decisions of the Executive Director of the Lottery, which decisions are, in his sole discretion, are binding and final. Failure to comply with the Official Rules may result in disqualification from the Promotion.

**2. ELIGIBILITY:** The Promotion is open to all persons who are 18 years of age or older. Employees of the Lottery and family members of employees of the Lottery, including spouse, child, brother, sister or parent residing as a member of the same household as their domicile are not eligible to enter or win.

**3. HOW TO ENTER:** There is one (1) method of entry ("Entry") for the Promotion in which qualified entrants must follow: Entrants must have or create a MA Lottery Player Account on the MA Lottery mobile app or through the Lottery website at <u>www.masslottery.com</u>. For every three (3) of the same non-winning eligible instant tickets: Game 387 – Billion Dollar Extravaganza (\$50), Game 409 - \$10,000,000 Cash Blast (\$20), Game 408 – Instant \$500's (\$10), Game 341 – \$4,000,000 Jumbo Cash (\$10), Game 396 – Big Blue Bonus Cashword (\$5), and/or Game 383 – Powerplay Cashword (\$2) scanned through the mobile app or manually entered through the Lottery website by following the link into the Promotion, the entrant shall earn one (1) entry into

the drawing. Entries shall only be counted for the same eligible non-winning tickets, until the total of three (3) of the same non-winning eligible instant tickets have been successfully submitted, only then one (1) entry into the drawing is awarded. Three (3) of the same non-winning tickets constitute one (1) entry.

To enter the promotion, only eligible non-winning tickets which are scanned for the first time through the mobile app or manually entered through the website during the Promotion period will be eligible; tickets scanned or entered prior to the Promotion period will not be eligible. The initial entry period of the Promotion begins on Monday, July 7, 2025, at 5:00:00 am ET and ends promptly on Monday, August 25, 2025, at 3:00 pm ET.

**4. SELECTION OF WINNERS:** Seven hundred and eighty (780) winners shall be randomly selected by the Lottery from all eligible entries received during the entry period. There will be an additional five hundred and eighty-five (585) entries selected as alternate winners in the event they need to be activated. The drawing will be conducted on or about Tuesday, August 26, 2025, in the sole discretion of the Lottery. The winners shall be announced by email within seven (7) business days of selection and verification by the Lottery. If the prize notification is undeliverable or in the event of any noncompliance with any of the Official Rules, the prize may not be awarded, and the Lottery may select an alternate winner. All prizes shall be awarded sequentially, and each previous winner shall move up the list in sequential order with the prize tiers adjusted accordingly. It shall be the sole responsibility of each entrant to notify the Lottery if his/her contact information changes. The Lottery is not responsible for false, incorrect, changed, or incomplete information. Players are limited to one (1) and only one (1) prize win per promotional period. If, in its sole discretion, the Lottery determines that an entrant failed to abide by these Official Rules or uses and/or attempts to use its mobile app or website, MA Lottery's Player account or participate in a manner other than for its intended purposes, the player's access to the mobile app and/or the MA Lottery Player Account may be suspended and/or terminated at the direction of the Executive Director, and no prize shall be awarded to the player. Nothing herein shall prohibit the right to gift a ticket purchased from a licensed Sales Agent pursuant to 961 CMR 2.27.

**5. PRIZES:** The total number of cash prizes available to be awarded for the Promotion is as follows: eighty (80) \$500, two hundred (200) \$200, and five hundred (500) \$100. There shall be no substitutions. Assignment and/or transfer of the prize is prohibited. Prize checks will be mailed to the address on winners' MA Lottery Player Account within two (2) weeks of notification. MA Lottery Player Account members are responsible for keeping their player account information current. A maximum of seven hundred and eighty (780) cash prizes in the amounts specified above will be awarded for the entire Promotion. All applicable, if any, expenses, fees or costs associated with the prize shall be the sole responsibility of the winners.

**6. DRAW PROCEDURES:** All entrants shall be assigned a number which will be associated with and identify an entrant's entry(s). All qualified assigned numbers will enter the drawing. Using a random number generator, the Lottery will randomly draw a number which shall be a winning number. The winning numbers drawn from the entire pool of qualified entries shall be deemed the winning numbers. The entrants whose mobile app accounts and the MA Lottery Player accounts associated with the winning numbers shall be declared the prize winners. In the event that any winner is disqualified, or the prize is undeliverable, the next sequential alternate from the same drawing shall be added to the winners list, and each previous winner shall move up the list in sequential order with the prize tiers adjusted accordingly. All 780 prizes shall be awarded, unless the Promotion is terminated, modified or suspended for any reason pursuant to Clause 12 herein notice shall be provided by posting same on the Lottery website.

**7. ODDS OF WINNING:** Odds of becoming a winner of the Promotion are dependent on the total number of eligible entries received during each weekly entry period.

**8. PRIVACY:** Personally identifiable information that is submitted by an entrant as part of the Promotion shall be used to administer the mobile app, the MA Lottery Player Account and the Promotion, select the prize winners, and fulfill the prizes, and will be treated in accordance with the Lottery's privacy policy, accessible at: <u>https://www.masslottery.com/about/privacy-policy</u>.

**9. SPONSOR:** The sole sponsor of the Promotion is the Massachusetts State Lottery Commission, 150 Mt. Vernon Street, Dorchester, MA 02125.

10. WINNER ANNOUNCEMENT/OFFICIAL RULES: For the names of the winners, available after the conclusion of the Promotion, winners' names shall be announced on the Lottery's website. For the names of winners, available after the conclusion of the Promotion, send a self-addressed, stamped envelope to: Massachusetts State Lottery, Player Account Official Rules - Scan to Enter - Super Summer Promotion, 150 Mt. **11. DISCLAIMER:** By entering the Promotion through the mobile app or through www.masslottery.com during an entry period, the entrant is entered into the Promotion for that respective entry period. The entrant assumes all risk and liability for any personal injury or damages caused or claimed to be caused by, arising out of or in connection with his/her participation in the Promotion and/or the acceptance and/or use of any prize, and hereby indemnifies, holds harmless and releases the Lottery, its respective constitutional office, subsidiaries, affiliates, officers, directors, agents, and employees from any and all such liability. The Commonwealth of Massachusetts, the Treasurer and Receiver General, the Lottery, its commissioners, directors, agents and employees of any of the foregoing are not responsible for technical, hardware, software, or cellphone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the user or by any of the equipment or programming associated with or utilized in the Promotion. By participating in the Promotion, the prize winner grants permission to the Lottery to use the winner's name, city, state, likeness and/or voice, biographical information and photo submission, if any for purposes of advertising, promotion, publicity, including all social media platforms without compensation of any kind.

**12. NON-PERFORMANCE:** If the Promotion is not capable of running as planned for any reason, including infection by computer virus, bugs, tampering, and unauthorized intervention,

fraud, technical failures, or any other causes beyond the control of the Lottery which corrupt or affect the administration, security, fairness, integrity of the game or Promotion, in its sole discretion, the Lottery may cancel, terminate, modify, or suspend the Promotion. The Commonwealth of Massachusetts, the Treasurer and Receiver General, the Lottery, its Commissioners, directors, agents and employees of any of the foregoing (i) assume no responsibility for any error, omission, interruption, deletion, defect, delay, in operation or transmission, in any manner, or communications failure, theft, destruction or unauthorized access to or alternation of entries, (ii) any mobile networks, any telephone or cellphone networks, computer on-line systems, servers or providers, computer equipment, software, failure of any email to be received by the Lottery due to technical problems, human error, or traffic congestion, or any combination thereof, including any injury or damage to the entrant or any other person's mobile phone or device related to or resulting from participation in the Promotion.

**13. DISPUTES/CHOICES OF LAW:** Except where prohibited, each entrant agrees that (1) any and all disputes, claims and causes of action arising out of or connected with the Promotion or any prize awarded shall be brought and are subject to the exclusive jurisdiction of the Commonwealth of Massachusetts, (2) any and all claims, judgements and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees, (3) punitive, incidental, special, consequential or other damages, including without limitation lost profits may be awarded (collectively "Special Damages") and (4) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
