

ADMINISTRATIVE BULLETIN 2025-05-06
FISHIN' FOR QUIC PICS PROMOTION

SECTION 1 – PURPOSE

The purpose of this Administrative Bulletin is to outline the rules and regulations and/or procedures for the Fishin' for Quic Pics Promotion (the "Promotion"). The Executive Director reserves the right to amend this Administrative Bulletin if he/she deems it to be in the best interests of the Massachusetts State Lottery Commission (the "Lottery").

SECTION 2 – DATES

The Promotion will commence on May 6, 2025 at 5:00 am and it will end on May 19, 2025 at 11:59 pm. All times in the Promotion refer to Eastern Time ("ET").

SECTION 3 – ELIGIBILITY

The Promotion is open to all persons who are eighteen years of age or older. Employees and family members of employees of the Lottery, including any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any employee of the Lottery, and employees of the Lottery's advertising agency are not eligible to enter or win.

SECTION 4 – DESCRIPTION

During the Promotion period, any time a player purchases a Mass Cash, The Numbers Game, Megabucks, Lucky for Life, Mega Millions, Powerball (collectively referred to as "Draw Game"), Keno, or The Wheel of Luck (collectively referred to as "Monitor Game) play for \$4 or more on a single ticket, the player will have the chance to win one (1) free \$1 Quic Pic for Mass Cash, Keno (3 spot), or The Numbers Game (First 3 Any), as determined by the Lottery. Quic Pic will be for the next available draw of Mass Cash, Keno, or The Numbers Game as determined by the Lottery.

SECTION 5 – PRIZES

When a player purchases \$4.00 or more on a single ticket of one of the Draw Games or one of the Monitor Games, the player has a chance to win one (1) free \$1.00 Quic Pic for a Draw Game or Monitor Game, respectively, the game of which shall be determined in the sole discretion of the Lottery. The prize of one (1) free \$1.00 Quic Pic shall be for the next available draw of Mass Cash, Keno, or The Numbers Game respectively.

SECTION 6 – GOVERNING LAW

By purchasing a ticket and accepting the free \$1 Quic Pic, a player agrees to comply with and abide by the laws of the Commonwealth of Massachusetts, all rules and regulations and final decisions of the Lottery, and all procedures established by the Executive Director concerning the Promotion. No \$4 or more Draw Game or Monitor Game ticket with or without a free \$1 Quic Pic shall be purchased by, and no prize shall be claimed by or paid to any of the

following persons: any member or employee of the Lottery or to any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any member or employee of the Lottery. No tickets shall be purchased by any person under the age of eighteen.

SECTION 7– EFFECTIVE DATE

The effective date of this Administrative Bulletin shall be May 6, 2025.
