LDAC

The Legislation Design and Advisory Committee provides pre-introduction advice. LDAC should be involved early in the process to help with design and other matters covered by the Legislation Guidelines.

**START** DATE

If the Bill is to be passed within the year, instructions must be provided to PCO as soon as possible in the first guarter of the year.

If the Bill is to be introduced, but not passed, within the year, instructions must be provided before 1 July.

EST. DAYS

The estimated time to draft a Bill (from instructions being received to Ministerial consultation before LEG) depends on the Bill's size and complexity. On average, it takes 67 working days (about 90 days) for a 50 clause Bill of medium complexity.

Number of working days for task to be completed.

Some steps may be able to be done at the same time. PCO can assist in putting together a realistic and achievable timetable.

Leader of the House informs Clerk of the House on any working day, or by 1 pm on a sitting day, of the Government's intention to introduce the Bill on that day

### Bill introduced

Regulatory Impact and Disclosure Statements published (Turning Policy Into Law <u>1.6</u>, <u>1.19</u>) Bill is available for first reading on the third working day following its introduction.

(SO 293(1))

Minister may present legislative statement immediately before moving first reading

(SO 272, Turning Policy Into Law 1.19A)
