

# **CORPORATE FUNDRAISER**

#### LOCATION: FLEXIBLE

Convergence is the global network for blended finance. We generate blended finance data, intelligence, and deal flow to increase private sector investment in developing countries. Blended finance is the use of catalytic capital from public or philanthropic sources to increase private sector investment in sustainable development. Convergence's global membership includes public, private, and philanthropic investors as well as sponsors of transactions and funds. Members include institutions such as MacArthur Foundation, FinDev Canada, the Nature Conservancy, and Credit Suisse. Convergence offers its members a curated, online platform to connect with each other on blended finance transactions in progress, as well as exclusive access to original market intelligence and knowledge products such as case studies, reports, training, and webinars. For market acceleration, Convergence provides grants through its Design Funding program, for the design of blended finance vehicles that could attract private capital at scale to global development.

Convergence is headquartered in Toronto, but the candidate's location can be flexible. We are seeking to retain an executive-level Corporate Fundraiser on a consultant basis for an initial 6-month period, with a possibility of extension.

#### **DESCRIPTION**

This role will report to the CEO. The Corporate Fundraiser will design and lead a strategic campaign to build Convergence's funding base among corporate foundations and other philanthropic partners beyond Convergence's existing network, contributing to the mission of an innovative start-up in the development finance space. Our goal is to secure USD 10 million in funding by 2025.

#### Fundraising / Reporting:

- Introduce and lead identification, research, and qualification processes to generate a prospect pipeline
- Devise strategies, targets, and a tailored action plan to secure USD 10 million of multi-year corporate funding to support Convergence's existing program
- In collaboration with Convergence management, develop key messages, marketing and briefing materials
- Cultivate, solicit, and steward prospects and donors, serving as an enthusiastic and well-informed spokesperson and ambassador for the organization
- Recommend and support events which raise awareness and support for the organization
- Maintain a fundraising database of prospect profiles, actions taken, and outlook for each opportunity
- Advise on the preparation of funding proposal submissions
