

Clinician's Brief & Zoetis Feline Challenge: Official Program Rules

Subject to all applicable federal, state, and local laws, regulations, and ordinances. Program begins at 12:00 AM Pacific Time (PT) on August 3, 2026, and ends at 11:59 PM PT on October 26, 2026 (the "program period"). Void outside of the fifty (50) United States, the District of Columbia, and Puerto Rico where prohibited by law.

Eligibility

The Program is open to all veterinary team members, licensed or unlicensed, located in the fifty (50) United States, the District of Columbia, and Puerto Rico, except where prohibited by law. Must be 21 years or older to participate. Employees, officers, and directors of Zoetis ("Sponsor") or Educational Concepts, LLC, and their affiliated organizations, partner companies, advertising and promotion agencies, entities furnishing prizes, or individuals/entities otherwise involved in the development and administration of the Program ("Program Entities") and their respective officers, directors, representatives and agents, their immediate families, and members of their households (whether related or not) are ineligible to enter the program or win a prize. Engagement with the Program must be recorded and submitted online. Program engagement details must be received by October 31, 2026, 11:59 PM PT. No purchase is necessary to participate.

Participants warrant and represent that they have secured the requisite consent from any third party involved with their entries.
