### Step up Centre (via Humana People to People India)

As part of our commitment to our local community, Lilly is the corporate partner for a 'Step-Up Centre' in the Jharsa area, just 5 minutes' walk from our Head Office in Gurgaon.

Working with Humana People to People India (HPPI) Step Up Centre give underprivileged children - many of whom are migrants - who are currently not enrolled in school an opportunity to receive a basic education, and prepare for joining a government school at their age appropriate level in the future. Alongside education, children and their families will also have the opportunity to learn about basic health and hygiene.

As the corporate partner for the Jharsa Step Up project Lilly employees can volunteer time, energy, ideas and resources, working alongside the children and their families to improve the Lives of those living in our Local community.

### MAMTA - HIMC (via United Way Delhi)

United Way of Delhi (UWD) is an independent local not for profit society, affiliated to the United Way Global Family one of world's largest leadership and support networks with 1800 affiliate members across 41 countries.

Reproductive Maternal, Newborn, Child, and Adolescent Health (RMNCH+A) conditions in India are very meager especially in the urban low resource settings. Adolescence, Pregnancy and Infancy are the most important phases of life, as it requires extra care on health, nutrition and life skills issues for the better maternal and child health outcomes.

United Way Delhi in partnership with MAMTA-Health Institute for Mother and Child, New Delhi has envisaged a Community based intervention to improve RMNCH+A status in the 1.25 lakh population, largely migrant and low-income groups, residing in South West Delhi and Gurugram. The project goal is enhancing determinants of Reproductive, Maternal, Neonatal, Child Health and Adolescent Health (RMNCH+A) by intervening among Adolescents (10-19 years), Pregnant and Lactating Women (15-49 years) and Health System in Urban Slums/Resettlement Colonies of South West Delhi/NCR by adopting Inclusive & Life Course Approach.

# **COVID 19 Emergency Relief**

In light of the outbreak of COVID-19 pandemic, Eli Lilly India worked towards supporting the Government of India and healthcare workers in the fight to curb and cure the spread of this disease through following initiatives –
