





In the aftermath of Bulgaria's liberation from Ottoman rule, a cohort of young men and women found a home in the European arts. This book follows the lives and works of the post-1878 generation of cultural producers who defined Bulgarian identity. A sweeping narrative of social and political change and personal adaptation, the book explores the country's evolving literary and artistic scene from the 1890s to the 1950s. It traces the impact of wars and coups, ideological shifts and state policies. The book highlights the contributions of key figures and professional associations, their struggles for artistic autonomy, and their efforts to bridge the gaps between high culture and mass entertainment, national and universal art. A portrait of a generation that transformed Bulgarian culture as it navigated the tumult of the early twentieth century, this book offers insights into the broader patterns of transformation, disruption, and cultural negotiation in modern Europe.




In February 2024 the designated body of the geological sciences rejected the proposition that humans have entered the Anthropocene epoch. Historians are yet to tell history as the interaction with materials and living beings. The history of forestry is a particularly promising subject to study. Environmental concerns and the largescale commodification of forests, often with state participation, have been walking hand-in-hand since at least the mid-eighteenth century. Moreover, the history of the development of forestry's standardised methodology is a global history. This book describes the efforts and experiences of trained foresters driven by competing priorities, as well as their impact on the society, landscape and politics of Hungary between about 1860 and 1975.





Ethnic Relations in the Baltic Reconsidered

This collected volume offers an original perspective on the Baltic region by examining the intricate relationships between its diverse ethnic groups from the mid-nineteenth century to the present. Rather than focusing solely on national narratives or comparisons of historical development, the book analyzes ethnic relations through the lenses of identity, governance, empire, and violence. The nearly constant redrawing of geographic borders and boundaries among communities during this period destabilized fixed identities, generating novel, hybrid ways of self-identification along with a hardening of oppositions. Innovative forms of coexistence came with violent, sometimes genocidal conflicts. The contributors explore topics such as evolving senses of belonging, the impact of imperial and Soviet rule, instances of cooperation and conflict, and the legacies of historical trauma. By incorporating new sources and interdisciplinary approaches, they update traditional understandings of nations and nationalism in the Baltic region and provide insights relevant to similar regions.



Gray is Beautiful Jeffrey Goldfarb



This study offers an ethnographic exploration of how memory, identity, and history are contested in the city of Opava and the surrounding Hlu.ín area – former sites of Austrian and Prussian rule shaped by post-imperial legacies, displacement, and shifting national narratives. Drawing on extensive fieldwork, the book investigates how local communities navigate dominant Czech nationalism and vernacular Silesian identities through memorials, oral histories, cultural expression, and tourism. Chapters explore themes such as Wehrmacht legacies, linguistic politics, and the branding of Silesian cuisine, revealing how cultural memory is selectively preserved, silenced, or commodified. Through rich case studies, the book highlights the tensions between official discourses and grassroots memory practices, showing how identity in this Central European borderland is continually reconstructed. Blending theoretical depth with lived experience, this study offers new insight into the role of collective memory in shaping belonging in post-imperial, postsocialist Europe.



Repercussions of communism are still felt throughout Central and Eastern Europe. In fact, specters of communism remain vivid enough to inspire a wide range of contemporary cultural production, from video games to museum exhibits. This volume demonstrates how the region remains in a state of transitioning away from communism, not having secured a fully post-communist identity.

The volume adopts an interdisciplinary approach to extend debates on the lasting impact of the communist era across Central and Eastern Europe with chapters thematically threaded through concepts including curation, immersion, interaction, humor and authenticity. 

The Croatian Diaspora in **Argentina**

Nikolina Zidek

Following the collapse of the fascist Independent State of Croatia (1941–1945), around 10,000 political émigrés fled to Perón's Argentina. This study traces the Croatian diaspora's evolution from its founding to the present. Initially marked by trauma—military defeat, exile, and reprisals—the community redefined its identity within Cold War geopolitics, first as victims of communism, later as champions of democracy. For decades, it viewed itself as guardian of the Croatian national cause. The establishment of independent Croatia in 1991 challenged this role, prompting reflection on whether to remain diaspora Croats or reintegrate into the homeland.

Drawing on archival research and oral testimonies, Nikolina .idek explores how intergenerational memory shaped identity across time. She shows how the community preserved its origins while adapting to new realities, ultimately transforming into "planetary Croats" who use social media and transnational networks to connect with Croatia and the global diaspora.

Nikolina Zidek is a Professor at IE University Madrid, School of Politics, Economics, and Global Affairs. She holds a Ph.D. in Political Science from the Complutense University of Madrid (UCM). Prior to her academic career, Dr. .Zidek served for twelve years as a Croatian professional diplomat.


Rethinking God after God

God is and remains a meaningful term, even after "the death of God," but its meaning is by no means clear or unambiguous. Clearly and with a broad perspective, this book challenges classical theology with the criticism that "onto-theology" is no longer possible today and shows in what drastically changed way it might "survive." It shows how the academic theological conversation about God after God has developed over time and in different places.

This book begins with the controversial work of Dutch theologian Harry Kuitert, who bid farewell to old representations of God but got stuck finding new ones. It turns back to the important and indispensable insights of Hegel and Heidegger. It presents contemporary post-theistic thinking about God, using German, French, and American thinkers, distinguishing interpretive theologians, deconstructionists, and constructive theologians, finally formulating a new position.

BIOGRAPHY

Rick Benjamins wrote a dissertation on Origen of Alexandria and was a minister from 1993 until 2008. He lectured on dogmatics and liberal theology at the PThU and the University of Groningen. From September 2022, he is professor of liberal theology at the PThU.
