I acknowledge and represent that, as per the internal policies and regulations of the company I represent and as per the U.S. Foreign Corrupt Practices Act of 1977 as amended and the U.K. Bribery Act 2010 as amended and the local laws applicable to me, I can accept the prize won at UiPath FORWARD event.

I also represent and warrant that:

- I was not involved in the design, production, paid promotion, execution, or distribution of the Contest.
- I am not an employee or contractor of UiPath including any of its affiliates of subsidiaries.
- I am the sole responsible for compliance with Export Laws, including without limitation the U.S. Export
 Administration Regulations administered by the U.S. Department of Commerce's Bureau of Industry and
 Security ("BIS") and economic sanctions administered by the U.S Department of the Treasury's Office of
 Foreign Assets Control ("OFAC"), European Commission regulations, United Nations Security Council
 resolutions, and other similar national or international regulations (collectively, "Export Laws").

- I am not identified on any applicable sanctions or restricted party list, including the Specially Designated
 Nationals and Blocked Persons List, Foreign Sanctions Evaders List, and Sectoral Sanctions Identifications
 List, administered by OFAC, and the Entity List, Denied Persons List, or Unverified List, administered by BIS
 or European Union Sanctions lists.
- I will need to be present to win and accept a prize.
- I will not export, re-export or otherwise transfer the prize, directly or indirectly, to any country, entity or other party that is ineligible to receive such items under the Export Laws.
