DECREE NO. 700 of 05/08/2024

Subject: Public notice for expression of interest pursuant to Article 7, paragraphs 5 bis, 5 ter, and 5 quater, of Law No. 240 of 30/12/2010 for the position of one Full Professor in the Scientific-Disciplinary Group 13/ECON-09 - Financial Intermediaries Economics and Corporate Finance - SSD ECON-09/A - Corporate Finance - at the Faculty of Economics and Law, Department of Management and Economics.

Considering Law 240 of December 30, 2010;

Considering the Statute of the Università Telematica Pegaso s.r.l. and subsequent amendments, published in GU No. 156 of 05/07/2019;

Considering Article 7, paragraphs 5 bis, 5 ter, and 5 quater, of Law No. 240 of 30/12/2010;

Considering Ministerial Decree No. 367 of 29/04/2022, defining implementation methods for mobility for calls in Universities and Public Research Bodies;

Considering the “Regulation for the discipline of calls for First and Second Tier Professors” of the Università Telematica Pegaso S.r.l., issued by Rector’s Decree No. 198 of 03/04/2024;

Considering the resolutions adopted by the Academic Senate and the Board of Directors in the sessions of 19/12/2023, regarding the activation of the position, received in the Academic Senate on 25/06/2024;

Considering Ministerial Decree No. 855 of 30/10/2015, concerning the redefinition of macro-sectors and competition sectors;

Confirmed that the necessary financial coverage for the position has been provided by the Board of Directors;

DECREES

Art. 1 - Type of Competition

A selection for Expression of Interest is announced, pursuant to Article 7, paragraphs 5 bis, 5 ter, and 5 quater of Law 240/2010, for the position of one Full Professor in the Scientific-Disciplinary Group 13/ECON-09 - Financial Intermediaries Economics and Corporate Finance - SSD ECON-09/A - Corporate Finance, at the Faculty of Economics and Law, Department of Management and Economics,

based on the correspondence of the project proposals presented by the candidates to the specific educational, research, or third mission needs outlined in this selection.

1. The submission of an application for expression of interest does not, in any case, entitle the candidate to admission to the procedures for access to the qualifications of University teaching staff.
2. The economic treatment, workload, and legal regime will be regulated according to the current Italian legislation, as well as the University's regulations.

Art. 2 - Admission Requirements

1. This procedure is open to:
 - a) Full Professors with at least five years of service at other Universities in the corresponding tier to which the selection refers;
 - b) Scholars permanently engaged abroad in research or teaching activities who have held an equivalent academic position at foreign Universities for at least five years, based on correspondence tables defined and updated every three years by the MUR, after hearing from the CUN;
 - c) Research managers and senior researchers at public research bodies or individuals employed on a permanent or fixed-term basis pursuant to Article 1, paragraphs 422 and following of Law 27 December 2017, No. 205, at scientific hospitalization and treatment institutes (IRCCS), engaged in translational, preclinical, and clinical research activities, provided they have been in service at the respective entity for at least five years and hold the national scientific qualification for the competition sector and tier to which the procedure refers.
2. Candidates are required to meet the requirements set by current legislation for aspiring Commissioners for the national scientific qualification procedures pursuant to Article 16 of Law 30 December 2010, No. 240.
3. The admission requirements must be met by the deadline for submitting the application.

Art. 3 - Exclusion Criteria

1. Individuals who, at the time of submitting the application, have a degree of kinship or affinity, up to the fourth degree inclusive, or a marital relationship with a Professor or Researcher belonging to the structure making the call, or with the Rector, the General Director, the Administrative Director, or a member of the University's Board of Directors, pursuant to Article 18, paragraph 1, letter c) of Law 240/2010, are not eligible to participate in the call procedures.

Art. 4 - Information on the educational, research, or third mission needs that the project must satisfy

1. Educational Needs

The "Scientific-Disciplinary Group (GSD) 13/ECON-09 - Financial Intermediaries Economics and Corporate Finance" and the "Scientific-Disciplinary Sector (SSD) ECON-09/A - Corporate Finance" are already present in various curricula of economics and management at UniPegaso (L18, LM47, LM56) and are strategically important for the University's need to strengthen and expand the educational offerings of undergraduate and master's degree courses in economics, with the goal of diversifying teachings in related disciplines, both nationally and internationally. This initiative is also linked to the University's expansion plans, which will lead to a significant increase in the Faculty of Economics and Law. Therefore, it seems appropriate to respond to this need with a highly qualified Full Professor with substantial experience in teaching activities.

2. Research Needs

In line with the development areas programmed by the University, and particularly by the Department of Management and Economics, research activities in the ECON-09/A sector must be characterized by

strong interdisciplinarity, aligning with the perspectives indicated in the University's Strategic Plan 2023-2025, the University's Research Plan, and the areas of the Pegaso doctoral programs. Specifically, the candidate's scientific output must demonstrate the ability to collaborate with international scholars, promote scientific exchanges with international research groups, with specific links to European and Asian scientific networks. A distinctive element is the possession of scientific production developed in the areas of international finance, commodities, financial technology, and sustainable finance. Furthermore, high-level documented experience in the editorial coordination of international scientific journals, research projects, and high-level training experiences, also internationally, in the field of corporate finance as a whole, is required.

3. Third Mission Needs

Third Mission activities should focus on the impacts on the territory and the socio-economic system among the developed research areas, integrating with the ongoing activities of the University and the objectives of the University's Strategic Plan 2023-2025.

Art. 5 - Criteria for evaluating projects admitted for evaluation

1. The Commission's evaluation criteria should prioritize:
 - a) the quality and international scientific level of the indicated research works, as well as their editorial placement;
 - b) the originality and innovativeness of the scientific production and methodological rigor;
 - c) the individual contribution of the candidate, analytically determined in collaborative works;
 - d) the consistency of the candidate's activity with the topics indicated in Art. 4 of this selection notice;
 - e) the innovativeness of the project proposal presented.

Art. 6 - Composition and constitution of the Selection Committee

1. The applications received are evaluated by a committee made up of three first-level professors, appointed through a decree of the Rector following a random selection from a shortlist of six candidates proposed by the Academic Senate, all of whom belong to the scientific-discipline group being assessed.
2. The call proposal, following the Commission's work, is deliberated by the Academic Senate and submitted for approval to the Board of Directors, which makes a decision within thirty days.

Art. 7 - Submission methods and deadline for applications

1. Expressions of interest can be written in Italian or English and must include:
 - a) application form (Attachment 1);
 - b) *curriculum vitae*;
 - c) list of selected publications in PDF format (maximum 12);
 - d) publications to be evaluated for the present selection, up to a maximum of 12;
 - e) project proposal consistent with the teaching, research, and third mission lines indicated in Art. 4 of this notice (maximum 1500 words);
 - f) any documentation proving the correspondence between Italian and foreign academic positions;
 - g) any other titles deemed useful for the selection procedure.
2. In the case of application submission by scholars permanently engaged abroad as referred to in Art. 2, a service certificate (also translated into Italian), issued by the home institution, indicating the held qualification, the relevant date of effect, and any equivalence to the corresponding academic position in Italian universities must be attached to the application.

3. Expressions of interest must be submitted, under penalty of exclusion, within the peremptory deadline of 15 days starting from the day following the public notice publication on the University's website.
4. The application and documentation (including publications to be submitted in PDF format) must be sent exclusively to the Certified Email address ufficio.concorsi@pec.unipegaso.it by 23:59 on the indicated deadline and must necessarily come from a certified email address. Titles and documents must not exceed 10 MB per submission. Each attached file must be named according to its type (e.g., "CV", "Identity Document", "Application Form", etc.). Expressions of interest received after the specified deadline will not be considered. If the expression of interest is timely but the attached documentation is late, the latter will not be considered.
5. It is possible to send the aforementioned documentation in multiple batches, ensuring that the total size of the entire documentation is declared at the time of submission. Furthermore, the candidate must clearly and unambiguously specify the corresponding reference to the submitted batches.
6. It is also possible to send the aforementioned documentation from a non-personal Certified Email address, provided that a proxy for the processing of personal data on behalf of the candidate is attached.

Art. 8 - Responsible for the Procedure
