







Rector's Decree No. 299 of 22 July 2024

SUBJECT: II Supplement to Annex B.3 of the Public Competition Notice, for qualifications and examinations, for admission to PhD Courses - 40 CYCLE with administrative headquarters at Universitas Mercatorum.

## THE RECTOR

**CONSIDERED** the Statutes of Universitas Mercatorum;

CONSIDERED D.M. 14 December 2021, n. 226 "Regulations on the accreditation of doctoral

establishments and courses and criteria for the establishment of doctoral courses by

accredited bodies";

**CONSIDERED** the current Universitas Mercatorum Research Doctorate Regulations;

CONSIDERED The D.M. 630 of 24 April 2024, which provided for the allocation, for the year

2024/2025, under the PNRR, Mission 4, component 2 "From Research to Enterprise" - investment 3.3 "Introduction of innovative doctorates that meet the innovation needs of enterprises and promote the recruitment of researchers from enterprises", of three-year doctoral scholarships co-funded by enterprises, for the attendance of

innovative doctorate courses;

CONSIDERED The Notice of Public Competition, for titles and exams, for admission to the PhD Courses 40 CYCLE - issued with D.R. n. 245 of 26 June 2024 - in particular the premises, which reserves the right to make any changes and additions, and art. 1,

paragraphs 5 and 6 that provide:

The number of places and scholarships indicated in the descriptive sheets attached to this call may be increased following any additional financial resources of the University, regional and/or national and/or European and/or international and/or PNRR and/or other external subjects; of each grant will be given appropriate publicity on the University's website at the following link: https://www.unimercatorum.it/ricerca/dottorati-di-ricerca in the dedicated section.

 Any additional positions or scholarships, subject to the acquisition of the necessary funding by external subjects and the signing of the relevant agreement, will be made known by a subsequent rectoral decree published on the University institutional

above-mentioned Public Competition Notice, containing the indication of the

positions with scholarship and the positions without scholarship;

**CONSIDERED** the D.R. no. 284 of 9 July 2024 which provides for the integration of Annexes B.1, B.2

and B.3 of the Public Competition Notice, based on qualifications and exams, for admission to the Doctorate of Research Courses – 40th CYCLE with administrative

headquarters at Universitas Mercatorum;

CONSIDERED the expression of interest in co-funding scholarships to be granted from PNRR

resources, pursuant to Ministerial Decree 630/2024, M4C2 - Inv. 3.3, received from

Genesis S.r.l., for the PhD course in "Sustainability and ESG agenda";

**CONSIDERED** the expression of interest to co-finance no. 2 scholarships using PNRR resources,

pursuant to Ministerial Decree 630/2024, M4C2 - Inv. 3.3, received from the company *Genesis s.r.l.*, for the doctoral course in "Sustainability and ESG agenda", as well as the willingness to welcome the recipients of the aforementioned scholarships at its headquarters for a study and research period of up to no. 18 months to be

carried out in the 3 years of the course;

CONSIDERED the deadline for the above-mentioned notice scheduled for 27 July 2023, 12:00

## ART.1

- 1. The number of scholarships foreseen for the PhD Course in "Sustainability and ESG agenda" (Annex Sheet B.3) is supplemented with:
  - N. 2 scholarships from PNRR resources, pursuant to Ministerial Decree 630/2024, M4C2
    Inv. 3.3, co-financed by *Genesis S.r.l.*
- 2. The substitution of the Description Sheet of the PhD Course in "Sustainability and ESG agenda" (Annex Sheet B.3), which is an integral part of the Call for Applications for the admission to the PhD Courses XL cycle issued with R.D. n. 245 of 26 June 2024 is authorised, providing for a total of no. 12 Places, of which: 9 with scholarship, 3 without scholarship.
