### **DECREE No. 1013 of 31/10/2024**

**Subject:** Public notice for the expression of interest pursuant to Article 7, paragraphs 5-bis, 5-ter, and 5-quater of Law No. 240 of 30/12/2010, for the coverage of 1 position of Full Professor in the Scientific-Disciplinary Group 12/GIUR-05 - Constitutional and Public Law - SSD GIUR-05/A - Constitutional and Public Law - at the Faculty of Economics and Law, Department of Law.

**Considering** la legge 240 del 30 dicembre 2010;

**Considering** the Statute of the Pegaso Telematic University S.r.l. and its subsequent amendments, published in the Official Gazette No. 156 of 05/07/2019;

**Considering** Article 7, paragraphs 5-bis, 5-ter, and 5-quater of Law No. 240 of 30/12/2010;

**Considering** Ministerial Decree No. 367 of 29/04/2022, which defines the implementation procedures regarding mobility for appointments in universities and public research entities;

**Considering** the "Regulation for the Discipline of Appointments of Full and Associate Professors" of the Pegaso Telematic University S.r.l., issued with Rector's Decree No. 198 of 03/04/2024;

**Considering** the resolutions adopted by the Academic Senate and the Board of Directors in the meetings of 19/12/2023, regarding the activation of the position, approved by the Academic Senate on 24/10/2024;

**Considering** Ministerial Decree No. 855 of 30/10/2015, concerning the redefinition of macro-sectors and competition sectors;

**Confirmed** that the necessary financial coverage for the advertised position has been provided by the Board of Directors;

## **DECREES**

### **Article 1 - Type of Competition**

A selection process is announced, pursuant to Article 7, paragraphs 5-bis, 5-ter, and 5-quater of Law 240/2010, for the Expression of Interest for the coverage of 1 position of Full Professor in the Scientific-Disciplinary Group 12/GIUR-05 - Constitutional and Public Law - SSD GIUR-05/A - Constitutional and Public Law - at the Faculty of Economics and Law, Department of Law, based on the

correspondence between the candidates' project proposals and the specific educational, research, or third-mission needs outlined in this selection.

1. The submission of an application for the expression of interest does not, in any case, entitle the applicant to admission to the procedures for accessing faculty qualifications at the University.
2. The economic treatment, workload, and legal status will be regulated according to current Italian regulations, as well as the University's regulations.

### **Article 2 – Admission Requirements**

1. The following individuals may participate in this procedure:
  - a) Full Professors who have been in service for at least five years at other universities in the corresponding academic rank for which the selection is called;
  - b) Scholars permanently engaged abroad in research or teaching activities who have held an equivalent academic position for at least five years at foreign universities, based on equivalence tables defined and updated every three years by the Ministry of University and Research (MUR), after consulting the National University Council (CUN);
  - c) Research directors and senior researchers at public research institutions or those employed in permanent or fixed-term positions, as per Article 1, paragraphs 422 and following of Law No. 205 of 27 December 2017, in scientific hospitals (IRCCS), conducting translational, preclinical, and clinical research, provided they have been in service at their institution for at least five years and hold the national scientific qualification for the relevant competition sector and rank.
2. Applicants must meet the requirements set by current regulations for candidates to the National Scientific Qualification Committees under Article 16 of Law 240/2010.
3. The requirements for admission must be met by the deadline for submitting the application.

### **Article 3 – Exclusion Criteria**

1. Individuals who, at the time of submitting the application, have a degree of kinship or affinity up to the fourth degree inclusive, or a marital relationship with a Professor or Researcher belonging to the structure making the appointment, or with the Rector, the General Director, the Administrative Director, or a member of the Board of Directors of the University, pursuant to Article 18, paragraph 1, letter c) of Law 240/2010, cannot participate in the selection process.

### **Article 4 – Information on Educational, Research, or Third Mission Needs to be Addressed by the Project**

#### **1. Educational Needs**

The SSD IUS/08 - Constitutional Law - is part of the current educational offerings of the Faculty of Economics and Law in the LMG01 degree program and is included in the strategic development plans of the Pegaso Telematic University for the coming years, in line with the University's Strategic Plan 2023-2025. This is due to its role as a foundational discipline for other national and international legal and socio-economic subjects, and its methodological function in the analysis and reconstruction of new institutional and social phenomena. In this context, the University requires a Professor with solid conceptual and doctrinal training, including from German-speaking countries, particularly in the area of constitutional private autonomy, and who has made significant contributions to the application of constitutional principles and freedoms in various sectors of the legal system (civil, procedural, administrative, tax, and criminal law). The candidate should also be an author of innovative interpretations of institutional facts related to economic sovereignty, the evolution of the constitutional system, European integration, and its impact on national governance systems, including the hierarchy of legal sources and the role of jurisprudence. Given the University's particular focus on digital society

innovations, the candidate should have substantial teaching experience in information law, communications, and media law, including in English.

## **2. Research Needs**

The expected research lines should focus on the constitutional status of the person, as the central point of a system of increasingly complex powers, and, in relation to this, the evolution of the organization, powers, and functions of national and European judicial bodies.

### **Article 5 - Evaluation Criteria for Accepted Projects**

1. The evaluation criteria for the Commission should prioritize:
  - a) The quality and international scientific level of the indicated research works, as well as their editorial placement;
  - b) The originality and innovativeness of the scientific production and methodological rigor;
  - c) The individual contribution of the candidate, as determined in collaborative works;
  - d) The alignment of the candidate's activities with the themes indicated in Article 4 of this selection notice;
  - e) The innovativeness of the proposed project.

### **Article 6 - Composition and Formation of the Selection Commission**

1. The applications received will be evaluated by a Commission composed of three Full Professors, appointed by Rector's Decree after a random draw from a list of six names proposed by the Academic Senate, from within the scientific-disciplinary group being evaluated.
2. The appointment proposal, following the Commission's work, will be approved by the Academic Senate and submitted for approval by the Board of Directors, which will decide within thirty days.

### **Article 7 - Application Submission Procedures and Deadline**

1. Expressions of interest may be submitted in Italian or English and must include:
  - a) Application form (Attachment 1);
  - b) *curriculum vitae*;
  - c) A list of selected publications (maximum 12) in PDF format;
  - d) Publications to be evaluated for this selection (maximum 12);
  - e) Project proposal consistent with the educational, research, and third-mission needs outlined in Article 4 (maximum 1500 words);
  - f) Any documentation proving the equivalence of the academic position in Italy and abroad;
  - g) Any other documents deemed useful for the selection process.
2. In the case of applicants permanently engaged abroad, as per Article 2, a service certificate (translated into Italian) from the institution of affiliation must be provided, indicating the position held, its start date, and any equivalence with the corresponding academic position in Italian universities.
3. Applications must be submitted, under penalty of exclusion, within 15 days from the day following the publication of the public notice on the University's website.

4. The application and documents (including publications in PDF format) must be sent exclusively to the certified email address: ufficio.concorsi@pec.unipegaso.it by 23:59 on the above-mentioned deadline and must come from a certified email address. Documents must not exceed 10 MB per submission. Each attached file should be named according to its type (e.g., "CV," "ID Document," "Application," etc.). Late submissions will not be considered.
5. The documentation may be sent in multiple parts, provided that the total size of the documentation is declared.
6. The documentation may also be sent from a non-personal certified email address, as long as it includes a power of attorney for data processing on behalf of the applicant.

#### **Article 8 - Procedure Responsible**
