DECREE No. 718 of 08/12/2024

Subject: Public Notice for Expression of Interest pursuant to Article 7, paragraphs 5-bis, 5-ter, and 5quater of Law No. 240 of 30/12/2010 for the coverage of 1 position of Associate Professor in GSD 10/ITAL-01 - ITALIAN LITERATURE - SSD ITAL-01/A – Italian Literature, at the Faculty of Humanities, Education, and Sports Sciences, Department of Literary, Linguistic, and Philosophical Studies.

Considering Law No. 240 of 30 December 2010;

Considering the Statute of Università Telematica Pegaso S.r.l. and subsequent amendments, published in GU No. 156 of 05/07/2019;

Considering Article 7, paragraphs 5-bis, 5-ter, and 5-quater of Law No. 240 of 30/12/2010;

Considering D.M. No. 367 of 29/04/2022, which defined the implementation modalities for mobility for appointments in Universities and Public Research Entities;

Considering the "Regulation for the Discipline of Appointments of Full and Associate Professors" of Università Telematica Pegaso S.r.l., issued with Rector's Decree No. 198 of 03/04/2024;

Considering the resolutions adopted by the Academic Senate and the Board of Directors in the meetings of 19/12/2023 regarding the activation of the position, received by the Academic Senate on 24/07/2024;

Considering D.M. No. 855 of 30/10/2015, concerning the redefinition of macro-sectors and competitive sectors;

Confirmed that the necessary financial coverage for the advertised position has been provided by the Board of Directors;

DECREES

Article 1 – Type of Competition

- An Expression of Interest is announced pursuant to Article 7, paragraphs 5-bis, 5-ter, and 5-quater of Law No. 240/2010, for the coverage of 1 position of Associate Professor in GSD 10/ITAL-01 -ITALIAN LITERATURE - SSD ITAL-01/A – Italian Literature, at the Faculty of Humanities, Education, and Sports Sciences, Department of Literary, Linguistic, and Philosophical Studies. The selection will be based on the alignment of the candidates' proposed projects with specific teaching, research, or third mission needs as outlined in this notice.
- 2. Submitting an application for this Expression of Interest does not, in any case, grant admission to the procedures for accessing faculty positions at the University.

3. The economic treatment, workload, and legal status will be regulated according to the current Italian legislation and the University's regulations.

Article 2 - Admission Requirements

- 1. The following may participate in this procedure:
 - a) Associate Professors with at least five years of service at other Universities in the corresponding academic rank;
 - b) Scholars permanently engaged abroad in research or teaching activities who have held an equivalent academic position at foreign Universities for at least five years, based on equivalence tables defined and updated every three years by the MUR, in consultation with the CUN;
 - c) Research directors and senior researchers at public research institutions or those employed on a permanent or fixed-term basis according to Article 1, paragraphs 422 and following of Law No. 205 of 27 December 2017, at scientific hospitals (IRCCS), who have been employed for at least five years at their institution and hold national scientific qualification for the competitive sector and rank relevant to the procedure.
- 2. Admission requirements must be met by the deadline for submitting applications.

Article 3 - Exclusion Criteria

1. Those who, at the time of application, have a degree of kinship or affinity up to and including the fourth degree, or a relationship of marriage, with a Professor or Researcher at the institution conducting the call or with the Rector, the General Director, the Administrative Director, or a member of the University's Board of Directors, according to Article 18, paragraph 1, letter c) of Law No. 240/2010, cannot participate in the call.

Article 4 – Information on Teaching, Research, or Third Mission Needs to be Addressed by the Project

Teaching Needs

The ITAL/01 scientific disciplinary sector is currently part of the curriculum offerings for the L10 and LM-14 degree programs with Italian Literature courses (covering over 48 CFU). It is also among the strategies for developing the teaching offer of Università Telematica Pegaso for the coming years, in line with the University's 2023-2025 Strategic Plan. This initiative is also connected to the University's expansion plans, which will lead to a significant increase in the Faculty of Humanities, Education, and Sports Sciences. Therefore, it seems appropriate to address this need with a highly qualified Associate Professor with extensive experience in teaching activities.

Research Needs

Research activities must be consistent with the guidelines outlined in the 2023-2025 Strategic Plan, the University Research Plan, and the areas of study and training of the Doctoral programs at Università Telematica Pegaso. This will contribute to the interdisciplinary approach that characterizes the study and research paths of the Faculty of Humanities, Education, and Sports

Sciences and the Department of Literary, Linguistic, and Philosophical Studies. The research project should advance knowledge in Italian literature over a broad chronological range and from a historical perspective that links the past and present. In this context, emphasis is placed on the relationship between Italian literature and mass culture, new forms of language, with particular attention to social, religious aspects, and gender writings. Special attention is given to research paths that explore the national and international dimensions, the reception and dissemination of Italian language and literary culture in Europe, with specific attention to the Central and Northern European contexts.

Third Mission Needs

In line with the 2023-2025 Strategic Plan, third mission and social impact activities should contribute to Università Telematica Pegaso's initiatives for the local community and the social and economic system within the developed research areas. Additionally, these activities should promote the university's participation in national and international scientific and cultural partnerships and collaborations.

Article 5 - Evaluation Criteria for Accepted Projects

- 1. The evaluation criteria for the Commission will prioritize:
 - a) the quality and international scientific level of the indicated research works, as well as their editorial placement;
 - b) the originality and innovativeness of the scientific production and methodological rigor;
 - c) the individual contribution of the candidate, analytically determined in collaborative works;
 - d) the alignment of the candidate's activity with the themes indicated in Article 4 of this notice;
 - e) the innovativeness of the proposed project.

Article 6 - Composition and Formation of the Selection Committee

1. The applications received are evaluated by a committee made up of three first-level professors, appointed through a decree of the Rector following a random selection from a shortlist of six candidates proposed by the Academic Senate, all of whom belong to the scientific-discipline group being assessed.

2. The appointment proposal, following the Committee's review, will be deliberated by the Academic Senate and submitted for approval by the Board of Directors, which will make a decision within thirty days.

Article 7 - Application Submission Procedures and Deadline

- 1. Expressions of interest can be drafted in Italian or English and must include:
 - a) application form (Attachment 1);
 - b) curriculum vitae;
 - c) list of selected publications in PDF format (maximum 12);
 - d) publications to be evaluated for this selection, up to a maximum of 12;
 - e) project proposal consistent with the teaching, research, and third mission lines indicated in Article 4 of this notice (maximum 1500 words);
 - f) any documentation proving the equivalence between Italian and foreign academic positions;

g) any other documents deemed useful for the selection procedure.

- 2. For applications from scholars permanently engaged abroad as per Article 2, a service certificate (also translated into Italian) issued by the institution of affiliation, indicating the held position, its start date, and any equivalence to corresponding academic positions in Italian universities, must be attached.
- 3. Expressions of interest must be submitted, under penalty of exclusion, within 15 days from the day following the publication of the public notice on the University's website.
- 4. The application and documentation (including publications in PDF format) must be sent exclusively to the Certified Email address ufficio.concorsi@pec.unipegaso.it by 23:59 on the stated deadline and must originate from a certified email address. Files must not exceed 10 MB each. Each attached file should be named according to its type (e.g., "CV", "ID Document", "Application Form", etc.). Expressions of interest received after the deadline will not be considered. If an expression of interest is timely but the documentation is late, the documentation will not be considered.
- 5. It is possible to send the documentation in multiple batches, ensuring to declare the total size of the entire documentation upon submission. Additionally, the candidate must clearly and unequivocally specify the reference corresponding to the submission.
- 6. Documentation may also be sent from a non-personal Certified Email address, provided that a proxy for personal data processing on behalf of the candidate is attached.

Article 8 - Procedure Responsible

Article 9 - Publication of the Decree
