# ● 獲獎作品的展示

# 1. 關於展示

GOOD DESIGN EXHIBITION 2025 是主辦單位與獲獎者共同合作,將獲獎作品的成果與價值傳達給社會,並與參觀者共享的平台。

為了讓非專業的一般參觀者也能理解作品的設計要點與特色,請進行簡潔明快的展示。

#### 1) 關於展示空間

每件獲獎作品的展示空間限定為1個展示單元,展示方式為以下三種之一:

①置於台面 ②置於地面 ③展板展示

由於會場空間有限,無法追加申請展示單元。

※尺寸限制請參閱 P13 起。

#### 2) 關於展示物

原則上,所有獲獎者必須展出作品實物。

若因尺寸、重量限制而無法搬入或無法展示(如建築、室內空間類作品,或服務等無形作品),獲獎者需準備可簡潔說明作品要點的展板等,作為替代展示。

如需使用輔助用具(如支架、透明罩等),請直接搬入完成品,避免在現場組裝。搬入時禁止使用會發出聲響的工具。

# 2. 展示的注意點

- ・若需使用宣傳冊、展板、動畫等輔助展示物件,請盡量簡潔呈現,嚴禁以商業宣傳為目的。
- 獲獎者布置完成後,如有違反展示規定、不符合展覽宗旨或影響其他參展者之情況,主辦單位有權調整, 必要時將予以撤除。
- ·若為體驗型展示、宣傳品發放等可讓參觀者觸碰作品的展示方式,請明確標示並自行管理 (如作品調整、宣傳品補充等)。上述方式所產生的廢棄物不得影響鄰近展位。
- ·展示影片必須設定為靜音,並以字幕等方式呈現必要資訊。
- •若展示刀具等具有安全風險的作品,請確實採取安全措施。

#### 3. 會場的留守

# 04 展示方式

# 1. 獲獎者的申請

通過二次評審的參評者需要在8月26日13:00JST~9月2日13:00JST進入Entry Site,登記 Exhibition Info. (展示方式、展示輔助物※可選),並確認獲獎作品的Release Info.。

由於會場空間有限,每件獲獎作品只能申請 1 個展示單元,展示方式為①置於台面、②置於地面、③展板展示中的一種。主辦單位將根據參評者提供的 Entry Data 決定每件作品的展示空間大小,並有可能直接指定作品的展示方式。不接受任何理由的追加空間申請。

#### 1) 關於展示方式

本次展覽秉持 GOOD DESIGN AWARD 的宗旨,根據獲獎作品的屬性,為獲獎者提供3種展示方式: ①置於台面 (Table Placement Package)、②置於地面 (Floor Placement Package)、③展板展示 (Panel Placement Package)。

#### 2) 關於各種展示配件

在展示中,如需要使用展板支架或電源等,請於8月26日13:00~9月2日13:00 JST透過Entry Site提出申請(詳見P17起)。

※不提供網路,如有需要請自行準備 Wi-Fi 設備。

#### 3) 標牌內容的確認

主辦單位將為參展作品製作說明用標牌,並統一張貼於展台等指定位置。原則上將使用8月26日13:00JST~9月2日13:00JST期間,獲獎者於Entry Site「Release Info.」登記並確認的資料。9月2日以後無法再行修改,請務必仔細確認。

GOOD DESIGN AWARD 獲 獎 展 作 品 主 要 展 示 於 Midtown Hall (B1F)、Midtown Conference (4F)、Design Hub (5F)。每件作品的展示位置由主辦單位依據獲獎作品的設計類別及所選展示方式統籌規劃,並將於 10 月下旬透過電子郵件通知各位獲獎者。一概不接受來自獲獎者的展示需求(例如:同一企業作品集中展示等)。

#### 2) 空間與展台設置

主辦單位將依照展示位置與獲獎者所選擇的展示方式,設置展台及相關展示輔助用品(電力服務、插座、展板支架等)。

#### 3) 展場內的照明

各展場內的照明將由主辦單位統一調整,以參觀者觀看便利為主。

#### 4) 標牌

標牌將依據獲獎者於 Entry Site 「Release Info.」中登記並確認的內容統一製作,並張貼於展台。標牌的內容與設置位置詳見  $P12\sim16$ 。




