GOOD DESIGN EXHIBITION 2024是主办方和获奖者一同,将获奖作品的成果和优点传达给社会,和参观者 共享的平台。为了专业外的一般参观者也能理解作品的设计要点和特点,请进行简洁、明快的作品展示。

1) 关于展示空间

每件获奖作品的展示空间限定为1个展示单元,具体展示方式为①置于台面、②置于地面以及③展板展 示中的一种。因会场展示空间的限制,无法追加申请展示单元。

2) 关于展示物

原则上要求所有获奖者必须展出获奖作品的实物。

若获奖作品为无法搬入或无法展示的对象(实物超出规定尺寸或重量的作品、建筑及室内等空间类作 品、服务类等无形作品),获奖者需准备能够简洁明了说明作品要点的展板等,代替实物展出。

需要辅助用具(支架、透明罩等)进行展示时,请直接将成品搬入,尽可能避免在现场组装。搬入作业时, 禁止使用发出声响的工具。

2. 展示的注意点

- ・若为了补充说明展示物而使用宣传册、展板、动画等辅助物品时,尽可能以简洁的方式呈现,禁止以商业 宣传为目的展示。
- · 获奖者的搬入布置结束后,如出现不遵守展示规定、不符合本展宗旨、影响其他获奖者的情况,主办方有 权进行调整,必要时进行撤除。
- 如果是进行体验型展示、宣传品发放等允许参观者碰触展示物时,请明确表示并自行管理展示物 (展示物 的调试、宣传品的补充等)。此外,因上述展示方式而产生的废弃物不能影响到相邻展位的作品。

3. 会场的留守

04 展示方式

1. 获奖者的申请

通过二次评审的参评者需要在 8 月 23 日 13:00 JST \sim 30 日 13:00 JST 进入 Entry Site,登记 Exhibition Info. (展示方式、展示辅助物※可选),确认获奖作品的 Release Info.。由于会场空间的限制,每件获奖作品只能申请 1 单元空间,展示方式为①置于台面、②置于地面以及③展板展示中的一种。主办方将根据参评者提供的 Entry Data 决定每件作品的展示空间大小,并有可能直接指定作品的展示方式。不接受任何理由的空间追加申请。

1) 关于展示方式

本次展览秉持GOOD DESIGN AWARD的主旨,根据获奖作品的性质,为获奖者提供3种展示方式:① 置于台面 (Table Placement Package)、②置于地面 (Floor Placement Package)和③展板展示 (Panel Placement Package)。

2) 关于各种展示配件

在展示中,如需要使用展板支架和电源等,也请在 8 月 23 日 $13:00 \sim 30$ 日 13:00 JST 通过 Entry Site 进行申请 (详见P17)。

※不提供网络,如需使用请自行准备wifi设备。

3) 标牌信息的确认

主办方将为参展作品制作说明用标牌,届时会统一贴付在展台等的指定位置。原则上将使用 8 月 23 日 13:00 JST ~ 30 日 13:00 JST 期间获奖者在 Entry Site 的"Release Info." 处登记、确认的资料。8 月 30 日以后,该资料无法变更,还请仔细确认。

2. 获奖展中主办方提供的服务

1) 展示位置的划分

GOOD DESIGN AWARD 获奖展作品主要将被展示于 Midtown Hall(B1F)、Midtown Conference(4F)和 Design Hub(5F)的展场。每件作品的展示位置由主办方根据获奖作品的设计类别和所选择的展示方式进行统筹规划,10月中旬通过邮件通知各位获奖者。一概不接受来自获奖者的展示希望(例如,同一企业作品的集中展示等)。

2) 空间和展台的设置

主办方将根据展示位置和获奖者所选择的展示方式,设置展台及相关展示辅助用品(电力服务、电源插座、展板支架等)。

3) 展场内的照明

各展场内的照明将由主办方以适于参观者观看为主旨,统一进行调配。

4) 标牌
