

**OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.**

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Timing:** The PG Good Everyday Rewards Sweepstakes (the “**Sweepstakes**”) begins 12:00:00 a.m. Eastern Time (“**ET**”) on 7/1/2024 and ends at 11:59:59 p.m. ET on 6/30/2025 (the “**Sweepstakes Period**”). The Sweepstakes will consist of twelve (12) drawing periods (each a “**Drawing Period**”) as described in the chart below. Each Drawing Period will begin at 12:00:00 a.m. ET on the start date and end at 11:59:59 p.m. ET on the end date.

- 2. Eligibility:** The Sweepstakes is open only to legal residents of the 50 states of the United States and the District of Columbia, who are 18 years of age or older as of the last day of the month prior to date of entry. 6. **Winner Notification:** Each potential winner will be notified via email (to the email address provided at the time of entry) and must respond to the email to confirm eligibility and provide their mailing address within three (3) days of notification in order to be confirmed as a winner. If a potential winner fails to respond within three (3) days, email notification is returned as undeliverable, entrant shall be deemed to be ineligible, the prize will be forfeited and an alternate potential winner will be selected.
