

**OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.**

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **Sweepstakes Timing:** The P&G x WNBA Finals Sweepstakes (the “**Sweepstakes**”) begins 12:00:01 a.m. Eastern Time (“**ET**”) on July 1, 2026 and ends at 11:59:59 p.m. ET on September 29, 2026 (the “**Sweepstakes Period**”).
2. **Eligibility:** The Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older as of the last day of the month prior to date of entry. Void where prohibited by law. All federal, state and local laws and regulations apply.
3. **HOW TO ENTER THE SWEEPSTAKES: There is NO PURCHASE NECESSARY to participate in the Sweepstakes. A purchase does not increase your chances of winning.**

- 5. Random Drawing:** One (1) winner will be selected in a random drawing on or about September 30, 2026 from among all eligible entries received during the Sweepstakes Period. Odds of winning are dependent upon the total number of eligible entries received during the Sweepstakes Period. Drawing will be conducted by Administrator whose decisions are final on all matters relating to the Sweepstakes.
- 6. Winner Notification:** The potential winner will be required to sign and return a Declaration of Eligibility and Liability Release and except where prohibited, publicity release ("**Declaration**") within forty-eight (48) hours of notification in order to be confirmed as the winner. If potential winner fails to return the completed Declaration within forty-eight (48) hours or Declaration is returned as undeliverable, entrant shall be deemed to be ineligible, the prize will be forfeited and an alternate potential winner will be selected, time permitting. Declaration will be sent via email.

Prize and Approximate Retail Value ("ARV"): 1 Prize:** A 3-day/2-night trip for winner and one (1) travel companion to the applicable location of the WNBA Finals (the "**Game Site**") for the purpose of attending one WNBA Finals game ("**Game**") selected in Sponsor's sole discretion ("**Trip**"). The Game is currently scheduled to take place in October 2026, however Game date is subject to change. Trip includes round-trip economy class air transportation from major commercial airport nearest winner's home to the Game Site and returning from the Game Site, two (2) nights hotel accommodations (based on double occupancy), two (2) tickets to the Game, a \$400 check to be used towards spending money and \$3,000 awarded as a check to help defray taxes for winner.
