

Addendum: This Sweepstakes has been updated to include the (2) additional Drawing Periods for the weeks of 11/22/2023-11/28/2023 and 12/20/2023-12/26/2023 (that are outlined in the Rules that there would be no drawings for). Each additional Drawing Period will have one (1) winner of one (1) Prize of a Sponsor specified P&G prize pack (ARV: \$150 each).
