

OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Timing:** The PG Good Everyday Rewards Sweepstakes (the “**Sweepstakes**”) begins 12:00:00 a.m. Eastern Time (“**ET**”) on 7/5/2023 and ends at 11:59:59 p.m. ET on 6/30/2024 (the “**Sweepstakes Period**”). The Sweepstakes will consist of fifty (50) weekly drawing periods (each a “**Drawing Period**”). Each Drawing Period will begin at 12:00:00 a.m. ET on the Wednesday of each week and end at 11:59:59 p.m. ET on the Tuesday of the following week (except for the last Drawing Period, which ends on Sunday, June 30, 2024).
