

OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Timing:** The PG Good Everyday Rewards Sweepstakes (the “**Sweepstakes**”) begins 12:00:01 a.m. Eastern Time (“**ET**”) on 7/1/2020 and ends at 11:59:59 p.m. ET on 12/30/2020 (the “**Sweepstakes Period**”). The Sweepstakes will consist of six (6) monthly drawing periods (each a “**Drawing Period**”) as broken out in the chart in Rule #3.
- 2.
