

**OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.**

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **Sweepstakes Timing:** The P&G Brand Sweepstakes (the “**Sweepstakes**”) begins 12:00:01 a.m. Eastern Time (“**ET**”) on July 1, 2023 and ends at 11:59:59 p.m. ET on June 30, 2024 (the “**Sweepstakes Period**”).
