

**OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.**

A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Timing:** The Dawn's & J.J. Watt's Ultimate Wash Party Sweepstakes (the "**Sweepstakes**") begins at 12:00 am Eastern Time ("**ET**") on January 29, 2024 and ends at 11:59 pm ET on February 16, 2024 (the "**Sweepstakes Period**").
- 2. Eligibility:** The Sweepstakes is open only to legal residents of the 48 contiguous states of the United States and the District of Columbia, who are 21 years of age or older as of the last day of the month prior to date of entry. Employees of The Procter & Gamble Distributing LLC (the "**Sponsor**"), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, including Don Jagoda Associates, Inc. ("**Administrator**"), the NFL Entities (as defined below in section 9) and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win. - 3. HOW TO ENTER THE SWEEPSTAKES: There is NO PURCHASE NECESSARY to participate in the Sweepstakes. A purchase does not increase your chances of winning.** During the Sweepstakes Period, there are two ways to enter:

Entries must contain all information to be eligible, otherwise the entry will be void.

All entries must be submitted by 11:59 pm ET on February 16, 2024 to be eligible. Limit one (1) entry per person during the Sweepstakes Period regardless of method of entry. Any attempt by any entrant to enter by using multiple/different email addresses, mailing addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified. Use of any automated or computer system to participate online is prohibited and will result in disqualification. Normal Internet/phone access and data/usage charges imposed by your online/phone service may apply.

- 4. Privacy:** Trust is a cornerstone of the Sponsor's corporate mission and the success of their business depends on it. - 5. Random Drawing:** One (1) Grand Prize winner will be selected in a random drawing on or about February 23, 2024, from among all eligible entries received within the Sweepstakes Period. Drawing will be conducted by Administrator whose decisions are final on all matters relating to the Sweepstakes. Odds of winning are dependent upon the total number of eligible entries received during the Sweepstakes Period.
- 6. Winner Notification:** The potential Grand Prize winner will be required to sign and return, via email, a Declaration and Liability/Publicity Release Form, where legal ("**Declaration**"). If potential winner fails to return the completed Declaration within three (3) days, entrant shall be deemed to be ineligible, the prize will be forfeited and an alternate potential winner will be selected. Return of prize notification as undeliverable or if winner is ineligible, it may result in disqualification and alternate selection. The Sponsor reserves the right to conduct a background check on potential Grand Prize winner in order to be confirmed as the Grand Prize winner. The Sponsor reserves the right in its sole discretion to disqualify potential Grand Prize winner based on the results of such background check or if

Sponsor determines in its sole discretion that awarding the prize to such potential Grand Prize winner might reflect negatively on Sponsor. Grand Prize winner will be required to provide his/her Social Security number for tax reporting purposes and background check. The Sponsor also reserves the right to conduct a background check on all guests the Grand Prize winner selects in order to be confirmed as a valid guest. The Sponsor reserves the right in its sole discretion to disqualify any potential guest based on the results of such background check or if Sponsor determines in its sole discretion that including the guest might reflect negatively on Sponsor. Guests will be required to provide their Social Security numbers for purposes of the background checks.

- 7. Prize and Approximate Retail Value (“ARV”): One (1) Grand Prize:** A 3-day/2-night trip for winner and up to nine (9) guests to the Scottsdale, Arizona area for the opportunity to have a “Wash Party” with J.J. Watt (“Event”). Grand Prize includes round-trip economy class air transportation on a carrier(s) of Sponsor’s choice between major airport (in Sponsor’s sole discretion) nearest winner’s/guest’s homes and Phoenix, AZ (or nearest airport, in Sponsor’s sole discretion), two (2) nights’ hotel accommodations (single occupancy at a hotel selected by Sponsor), up to \$1,000 in ground transportation gift cards, awarded in the form of up to ten (10) \$100 gift cards in Sponsor’s sole discretion, select food during the Event (in Sponsor’s sole discretion) and up to \$11,000 awarded as a check to winner to help offset tax liability on the Grand Prize. If Grand Prize winner has less than nine (9) guests, the tax offset check will be equal to 25% of the ARV of the prize up to the maximum of \$11,000. The maximum ARV of the Grand Prize is \$43,500. Any guests who show up at the Event beyond the up to nine (9) confirmed guests will not be able to attend and will be turned away at the door. All federal, state and local taxes on prize receipt and/or use are the responsibility solely of the Grand Prize winner. In no event will Sponsor be obligated to award more than the stated prize.

Sponsor (as identified in these Official Rules) is not responsible for the failure of any email or entry to be received by Sponsor on account of technical problems or congestion on the internet or at any website. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. **Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes or website may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.** Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If, for any reason, the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes or website, then the Sponsor reserves the right at its sole discretion to cancel the Sweepstakes and select the winner from among all eligible entries received prior to cancellation. By entering the Sweepstakes, you hereby represent and warrant that you have read these Official Rules and are fully familiar with its contents.

Release and Limitations of Liability/Publicity Release:** By participating in the Sweepstakes, the entrants and any guest agrees that Sponsor, Administrator, their respective parents, subsidiaries, affiliated companies, agents, retailers, advertising and promotion agencies (collectively, "**Sweepstakes Indemnities**") and the NFL Entities (as defined below) and each party's respective affiliates, officers, directors, agents, and employees will have no liability or responsibility for any claim arising in connection with participation in the Sweepstakes or the awarding of the prize or participation in any prize travel.
