When you can enroll in benefits

There are a few windows of time each year when you can enroll or change your benefits:

- New Hire or Status Change: Your benefits are effective on your first day of employment or movement to
 full-time or part-time status, and you have 30 days to complete your enrollment.
- Qualifying Life Event (QLE): You may be eligible to enroll or make changes to your benefits if you experience a QLE, such as getting married, having a baby, or losing coverage elsewhere. You have 30 days from the date of the event to complete your enrollment and provide the required documentation.
- Annual Enrollment: During Annual Enrollment, you can add, change, or remove benefits without a QLE.

 Ulta Beauty's Annual Enrollment typically happens in the summer and benefits go into effect on September 1st.

When it's time for you to enroll

Use this enrollment checklist to ensure that you and your family have just the right benefits you need during your new hire, employment status change, QLE, or Annual Enrollment period.

- Review your benefit options at the Ulta Beauty benefits site at https://learn.bswift.com/ulta
- Gather information you will need to enroll:
 - Dependent/beneficiary names, addresses, phone numbers, and Social Security Numbers
 - Proof of dependent eligibility, such as recent tax filing and marriage certificate, or birth certificate
 - Qualifying life event documentation, if applicable
- Review current benefits

- Log in to the bswift benefits portal at https://ultabenefits.bswift.com to:
 - Review plan rates and documents
 - Enroll or waive coverages
 - Confirm eligibility of or add eligible dependents
 - Eligible dependents include legal spouses, domestic partners, and children under the age of 26. Valid proof of relationship may be required.
 - Review and update your beneficiary designations
 - Save, print, and review your Enrollment Confirmation statement
