

Pacific Toyota Dealers Fall 2025 Tires Giveaway' Contest Official Rules & Regulations

THIS CONTEST IS OPEN TO BRITISH COLUMBIA AND YUKON RESIDENTS ONLY AND IS GOVERNED BY CANADIAN LAW

ELIGIBILITY: The Pacific Toyota Dealers 'Fall 2025 Tires Giveaway' Contest (the "Contest") is open to legal residents of the province of British Columbia and Yukon who are at least 19 years of age at the time of entry. The Contest is not open to employees, representatives or agents (or those with whom they are domiciled, whether related or not) of the Pacific Toyota Dealers (the "Sponsor"), its member dealers, Toyota Canada Inc., or their respective agents/affiliates (collectively the "Contest Parties"). By entering this Contest, the entrant represents that they have read, understood and agreed to comply with these Official Contest Rules & Regulations ("Official Rules"). Entry into this Contest constitutes your acceptance of, and agreement to be legally bound by, these Official Rules.

The Contest opens on Wednesday, October 15, 2025, at 9:00 AM PST and closes at 5:00 PM PST on Wednesday, December 31, 2023 (the "Contest Period").

HOW TO ENTER: NO PURCHASE NECESSARY. To enter, eligible participants must complete the online entry form available at www.shoptoyota.ca/pacific/en/tire-contest by entering their first and last name, valid email address, postal code, and (ii) signify agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules. Once you have fully completed the entry form with all required information, click the "submit" button to complete your entry (the "Entry").

To be eligible, your Entry must be submitted and received within the Contest Period.

ENTRY LIMIT: Limit one (1) Entry per person. For greater certainty, you can only use one (1) email address to enter the Contest. If it is discovered that any person has attempted to: (i) obtain more than one (1) Entry per person; and/or (ii) use (or attempt to use) multiple names, multiple identities and/or more than one (1) email address to enter the Contest, then (in the sole and absolute discretion of the Sponsor) they may be disqualified from the Contest and all of their Entries voided. Your Entry will be rejected if (in the sole and absolute discretion of the Sponsor) the entry form is not fully completed with all required information. Use (or attempted use) of any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest is prohibited and is grounds for disqualification by the Sponsor. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) to participate in this Contest. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification.

PRIZE DETAILS AND DRAW: There will be a total of one (1) prize available to be won, consisting of one (1) set of four (4) tires from a Pacific Toyota dealership of your choice to the maximum retail value of \$2,000 CDN. Prize includes tires only. Rims, accessories and installation not included. Winner Selection: One eligible Entry will be drawn at random at or around 9 A.M. on Tuesday, January 13, 2026, from among all eligible Entries received in accordance with these Official Rules. The odds of winning depend on the number of eligible Entries received.

Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Sponsor in its sole and absolute discretion). No substitutions are permitted, except at Sponsor's option. Sponsor reserves the right, in its sole and absolute discretion, to substitute the prize or a component thereof with a prize of equal or greater value. The prize will only be awarded to the person whose verifiable full name and valid email address appears on the entry form. All aspects of prize are subject to availability and subject to change.

WINNER NOTIFICATION AND CONFIRMATION: The Sponsor or its designated representative will make a minimum of two (2) attempts to contact the selected entrant using the information provided on the entry form within five (5) business days of the draw date. If the selected entrant cannot be contacted as outlined above, or if there is a return of any notification as undeliverable; then they will be disqualified (and will forfeit all rights to the prize) and the Sponsor reserves the right, in its sole and absolute discretion, to randomly select an alternate eligible entrant from among the remaining eligible Entries (in which case the foregoing provisions of this section shall apply to such new selected entrant).
