**"Ultimate Summer Road Trip" Contest**

**Official Rules & Regulations**

**THIS CONTEST IS OPEN TO BRITISH COLUMBIA AND YUKON RESIDENTS ONLY AND IS GOVERNED BY CANADIAN LAW**

**ELIGIBILITY:** The Pacific Toyota Dealers & The Coastal Jazz and Blues Society 'Ultimate Summer Road Trip' Contest (the "Contest") is open to legal residents of the province of British Columbia and/or the Yukon who are at least 19 years of age at the time of entry. The Contest is not open to employees or representatives (or those with whom they are domiciled, whether related or not) of the Pacific Toyota Dealers (the "Sponsor"), its member dealers or their respective agents/affiliates (collectively the "Contest Parties"). By entering this Contest, the entrant represents on behalf of him/herself that the entrant has read, understood and agreed to comply with these Official Contest Rules & Regulations ("Official Rules"). Entry into this Contest constitutes your acceptance of these Official Rules.

The Contest opens on Friday, June 21, 2024 at 12:01 AM PT and closes at 11:59 PM PT on Sunday, June 30, 2024 (the "Contest Period").

**HOW TO ENTER: NO PURCHASE NECESSARY.** To enter, participants must complete the online entry form by entering first and last name, email address, postal code, phone number, and (ii) signify agreement that they have read and agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules"). Once they have fully completed the Entry Form with all required information, they must click the "submit" button to complete the entry (the "Entry"). To be eligible, Entries must be submitted and received within the Contest Period.

**ENTRY LIMIT:** Limit one (1) Entry per person/email address. For greater certainty, participants can only use one (1) email address to enter the Contest. identification) to participate in this Contest. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification.

Winner Selection: One entry will be drawn at random at or around 9:00 AM PT on Tuesday, July 2, 2024 from among all eligible entries received in accordance with these Official Rules. The odds of winning a prize depends on the number of eligible entries received.
