**Pacific Toyota Dealers "Ultimate Big White 2024" Contest
Official Rules & Regulations**

**THIS CONTEST IS OPEN TO BRITISH COLUMBIA AND YUKON RESIDENTS ONLY AND IS
GOVERNED BY CANADIAN LAW**

ELIGIBILITY: The Pacific Toyota Dealers "Ultimate Big White 2024" Contest (the "Contest") is open to legal residents of the province of British Columbia and the Yukon who are at least 19 years of age at the time of entry. The Contest is not open to employees or representatives (or those with whom they are domiciled, whether related or not) of the Toyota Pacific Dealers Association (the "Sponsor"), its member dealers or their respective agents/affiliates (collectively the "Contest Parties"). By entering this Contest, the entrant represents on behalf of him/herself that the entrant has read, understood and agreed to comply with these Official Contest Rules & Regulations ("Official Rules"). Entry into this Contest constitutes your acceptance of these Official Rules.

The Contest opens on Friday, August 2, 2024 at 9:00 AM PDT and closes at 5:00 PM PDT on Friday, August 16, 2024 (the "Contest Period").

HOW TO ENTER: NO PURCHASE NECESSARY. To enter, participants must complete the online entry form by entering first and last name, email address, postal code, phone number and (ii) signify agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules"). Once you have fully completed the Entry Form with all required information, click the "submit" button to complete your entry (the "Entry").
