

Pacific Toyota Dealers "Whistler Mountain Bike Park" Contest

Official Rules & Regulations

THIS CONTEST IS OPEN TO BRITISH COLUMBIA AND YUKON RESIDENTS ONLY AND IS GOVERNED BY CANADIAN LAW

ELIGIBILITY: The Pacific Toyota Dealers "Whistler Mountain Bike Park" Contest (the "Contest") is open to legal residents of the province of British Columbia and the Yukon who are at least 19 years of age at the time of entry. The Contest is not open to employees or representatives (or those with whom they are domiciled, whether related or not) of the Toyota Pacific Dealers Association (the "Sponsor"), its member dealers or their respective agents/affiliates (collectively the "Contest Parties"). By entering this Contest, the entrant represents on behalf of him/herself that the entrant has read, understood and agreed to comply with these Official Contest Rules & Regulations ("Official Rules"). Entry into this Contest constitutes your acceptance of these Official Rules.

The Contest opens on Friday, July 19, 2024 at 12:01 AM PDT and closes at 11:59 PM PDT on Sunday, July 28, 2024 (the "Contest Period").

HOW TO ENTER: NO PURCHASE NECESSARY. To enter, participants must complete the online entry form available by entering first and last name, email address, postal code, phone number, and (ii) signify agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules"). Once you have fully completed the Entry Form with all required information, click the "submit" button to complete your entry (the "Entry").

PRIZE DETAILS AND DRAW: There will be one (1) grand prize available to be won, including two (2) 2025 unlimited Whistler Mountain Bike Park season passes. Approximate retail value: \$1,838.00 CDN.

Winner Selection: One (1) entry will be drawn at random at or around 9 A.M. on Monday, July 29, 2024 from among all eligible entries received in accordance with these Official Rules. The odds of winning a prize depends on the number of eligible entries received.

Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (except as may be specifically permitted by Sponsor in its sole and absolute discretion).
