### September and December meeting highlights

# Our Council meets six times a year, here's what's been on the agenda recently...

In September, Council welcomed Shirine Khoury-Haq to her first meeting after she was appointed as Co-op's permanent CEO, where she provided an update on business and commercial performance. Joined by our Chief Operating Officer, Chris Whitfield, and Director of Strategy & Transformation, Emma Hannah, Council Members heard about plans for the future and work that was being done now to navigate current external challenges, including business changes and restructures, the sale of Co-op's Petrol Forecourts business, our 'Lower prices, Local to you' campaign, reducing debt levels and tackling increased costs.

As the Cost-of-Living Crisis continues to impact society and our communities, Council Members were particularly keen to focus on how Co-op was 'Co-operating for a Fairer World' in challenging times. Meeting with directors in breakout groups, Council Members raised questions and shared ideas for how Co-op could support members and customers through its missions and could adopt its plans for current circumstances. In the afternoon, Council also received an update on Co-op's Diversity & Inclusion Strategy, which Council's Diversity & Inclusion Working Group has had input on, before spending some time discussing how to improve ways of working and governance structures. In December, Council met for the final time in 2022, focusing on the theme of balancing sustainability with affordability. Following another business performance update, it heard from Food Managing Director, Matt Hood, as he talked through Co-op Food's new strategy and plans for implementation, incorporating input from Council Members at our July Council Meeting. Co-op's Director of Public Affairs & Campaigns, Paul Gerrard, also joined to update on our Climate Justice Campaign.

Meeting with directors, Council Members discussed our ethical and sustainable commitments and how we continue to prioritise these in challenging times. Feedback from these sessions will be shared with our Co-op Board at its next meeting. To end the meeting, Council split into breakout groups led by Senate Members, where they talked through priorities for delivering the first year of the Three-Year Plan.

We represent you and we've identified three priorities for our work in 2023:

- Co-operating for a Fairer World in Challenging Times

- Member Value, Business Performance & Effective Governance

- Member Participation & Community

### **Discussions with directors**

To hold our Co-op Board to account on important issues for our businesses and members, Council Members ask questions as part of Directors' Forums...

## Catch up with our Council Committees

Council Members also meet in smaller groups throughout the year to input into plans and ask questions on areas of our co-op difference. Here's what they've worked on recently...



### **Member Value:**

Our Member Value & Business Performance Committee met with our Interim Chief Financial Officer for the first time and discussed Co-op's 2022 Interim Results, business reporting, protecting our Co-op during challenging times, and the latest business financials.

### Member Voice:

Our Member Voice Committee agreed strategic recommendations to our Board for Co-op's 2023 AGM. It also received an update on Member Participation work and plans for the Co-op Collective, as part of wider activity between Council and the business to evolve our Member Participation Strategy.

#### **Co-operative Leadership:**

Senate helps to co-ordinate Council activities and connects Council to Co-op's Board and Executive. Recently, it's hosted an away day and approved changes to processes to increase Council interaction and collaboration and build stronger relationships with the Board and business. Our Governance Committee looks at the effectiveness of Council and our ways of working. In the last few months, it's also agreed strategic recommendations for Co-op's 2023 AGM and supported the launch of a private Council Facebook Group for internal communications.

### Ethical & Sustainable Leadership:

Our Ethical & Sustainable Leadership Committee received an update from Co-op's Agriculture team in response to a letter it drafted. It also heard from our Property Sustainability team, learnt more about our WWF Basket Commitment and discussed its objectives for 2023.
