

## ELECTIONS AND AGM CO-OP LIVE PRIZE DRAW

### Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry instructions are deemed to form part of the Terms and Conditions. By entering this promotion all participants will be deemed to have accepted and be bound by the Terms and Conditions and to their details being communicated to the Promoter's representatives so that the Promoter or its representatives can contact the participant in connection with the promotion (as necessary). Please retain a copy for your information.

1. **PROMOTER:** This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to "we", "us" or "our" in these terms and conditions are references to the Co-operative Group Limited.
2. **OPENING AND CLOSING DATE:** This promotion opens at 08:00 on 1 June 2025 and closes at 23:59 on 30 June 2025 (the 'Promotional Period'). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.
3. **ELIGIBILITY:** This promotion is open to residents of the United Kingdom who are Members of the Co-operative Group only. Entrants must be aged 18 or over. Co-op Group employees can enter, however, any employees from its group undertakings and employees of its agencies directly connected with the creation and administration of this promotion are excluded. We may ask the winners to provide proof of age.
4. **HOW TO ENTER:** To enter, an entrant must be a valid Co-op Member and have participated in the elections and voting process, as referred to below, in April or May 2025 for the Co-operative Group Limited Annual General Meeting ("**AGM**").

To be deemed to have participated in the election and voting process, Entrants must have voted for:

1. the elections of the Council; and
2. elections for the Member Nominated Directors; and
3. the Motions presented at the AGM.
4. the elections for the Member Nominated Directors and the Motions if they are voting in Isle of Man, East of England or Northern Ireland, where the Council Elections are uncontested or there isn't an election in 2025.

Entry to the Co-op Live Experience prize draw will be automatic. Entrants will be placed into the draw once they have been deemed to have taken part in the full election and voting process as detailed in this clause "HOW TO ENTER".
