

2026 AGM Feedback Survey

£50 Prize Draw - Terms and Conditions

1. PROMOTER: This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to “we”, “us” or “our” in these terms and conditions are references to the promoter.

2. OPENING AND CLOSING DATE: This promotion opens at 1pm on 16 May 2026 and closes at 23:59 on 22 May 2026 (the “Promotional Period”). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.

3. ELIGIBILITY: This promotion is open to UK residents who are members of the Co-operative Group who are aged 16+ only. Co-op Group employees can enter, however, employees of the promoter (or any of its group undertakings and its agencies) who are directly connected with the creation and administration of this promotion are excluded from entering this promotion. The entrant must have completed the 2026 AGM Feedback Survey and have entered the prize draw within the Promotional Period in order to be eligible. One entry per member.

4. HOW TO ENTER: All members who registered to attend the 2026 AGM at Co-op Live, the pop-up event at Canalside Café, one of 12 AGM Local Events or the AGM Online Event will receive an email inviting them to complete the 2026 AGM Feedback Survey at 1pm on 16 May. Those in attendance at Co-op Live or an AGM Local Event will also have the opportunity to complete a hard copy of the survey.

To enter the prize draw, members must follow the link to the 2026 AGM Feedback Survey and complete the questions asked. Once submitted, the member will be automatically entered into the prize draw.

5. PRIZE: One prize of a credit of £50 on the winner’s membership card. The prize will be credited to their Co-op Membership card once confirmed as per clause 7. The prize is not exchangeable, and no cash alternative can be requested. The prize is provided at our discretion, and we may substitute or change it for a prize of an equivalent or greater value if circumstances beyond our control make it necessary to do so.

6. WINNER SELECTION: Within 7 days of the Promotional Period ending, the winner will be selected at random from all entries received using a randomised computer generator. The Promoter and its agents will not be responsible for the non-inclusion of entries as a result of technical failures or otherwise, including as such failure which is within the control of the Promoter or its agents. Proof of submission of entry is not proof of receipt of entry.

7. NOTIFICATION: The winner will be notified within 10 working days of the competition closing via the email address associated with their prize draw entry. If any winner declines a prize or fails to acknowledge the winning confirmation email or phone call within 5 working days, they forfeit any right to the prize and another winner will be drawn using the same process as detailed at clause 6 (Winner Selection) above.
