1. What do you regard as the most important priority for Co-op in 2025?

Supporting our members, colleagues and local community groups through the current cost of living challenges has to continue to be a top priority for the Co-op. Our members tell me

they want good value for their money at the same time as maintaining high quality in our products, supporting British farming and Fairtrade.

#### 2. How do you demonstrate a commitment to Co-op Values and Principles?

I'm a long-time member of Co-op and served as a Co-operative Party Councillor on Nottingham City Council for 10 years. I bank with the Co-operative Bank, and I use Co-op Insurance and Co-op Food stores. I took part in a 'sleep out' at Meadow Lane Football Stadium in Nottingham to raise funds for people who are homeless. I also served as a volunteer Police Constable for Nottinghamshire Police for 2 years. If I'm lucky enough to have your support and be elected to the Co-op Council again, I'll be working hard on behalf of our members to keep co-operative values at the heart of the business.

## 3. How will you add value to the Members' Council and what skills and experience would you use to do this?

1. What do you regard as the most important priority for Co-op in 2025?

1. What do you regard as the most important priority for Co-op in 2025?

In these times of inflation with household budgets being stretched to the limit with a record number of hard-working families depending on food banks just to exist, I believe that our

top priority must be to continue to strive to deliver the best possible value for our members and everyone who shops at the Co-op while using our vast resources to support our members in every way possible during these economically difficult times.

Where there is poverty, desperation and lack of public funding for essential services, it allows crime to prevail. Like many retail organisations, the Co-op continues to suffer losses through theft while colleagues increasingly fear for their safety due to the aggressive behaviour of a minority. I want to see the Council focus on taking further steps to prevent retail crime but more importantly, seek ways to protect our colleagues on the frontline by developing further policies and practical measures to deter those who seek to intimidate colleagues and members within our stores. One positive tactic would be to provide training for our colleagues on how to stay safe when facing aggressive and potentially violent behaviour.

#### 2. How do you demonstrate a commitment to Co-op Values and Principles?

I believe in the concept of a big society being served by a small state and by small corporations. The power to change our society for the good lies with the people. I have demonstrated this in practical ways as an NHS Responder through the Royal Voluntary Service and as a team member of a local social enterprise providing communication, information friendship, support and entertainment through the medium of community broadcasting.

I understand, based on active experience, that when people come together with energy and ambition and in a spirit of collaboration, anything can be achieved.

I don't just believe in co-operative values - I live them.

## 3. How will you add value to the Members' Council and what skills and experience would you use to do this?

I will add value by bringing in my experience as a former special (volunteer) police officer, what I have learnt about society, communication, teamwork and co-operation during my time as an elected borough councillor and my experience as a director of a successful telecoms company. This will enable me to listen to ideas, collaborate with colleagues and offer opinions and different viewpoints to the subjects that we will be discussing with the shared objective of producing polices that are equitable as well as

1. What do you regard as the most important priority for Co-op in 2025?

1. What do you regard as the most important priority for Co-op in 2025?

The most important priority for the Co-op in 2025 is to be a successful consumer co-operative, both in terms of financial results and member control and engagement. In practical terms,

that means encouraging members to spend more at the Co-op through member pricing, increasing rather than decreasing the range of Co-op own-brand products available, the return of a proper dividend scheme, and encouraging them to invest in the Co-op (as other co-operatives do) through depositing share capital and member investment bonds. In relation to democracy and member engagement, the National Members' Council needs to continue to constructively challenge and hold the Board to account within the powers available to it and members should be encouraged to participate in the democracy at the Co-op. Members also need to be better engaged at the local level. For example, by holding local meetings and store forums in liaison with Member Activators.

#### 2. How do you demonstrate a commitment to Co-op Values and Principles?

I demonstrate a commitment by trading as much as possible with the Co-op and other co-operatives, buying products produced by other co-operatives (e.g. Fairtrade) and by my current and past involvement in the Co-operative Movement. For example, I am a former member of both a Co-op Area Committee and a Co-op Regional Values & Principles Committee, a former governor at a co-operative school and I am the Treasurer of the Co-operative Press. In addition, I am a member of a number of co-operatives and other organisations that form part of the sector (e.g. the UK Society of Co-operative Studies).

## 3. How will you add value to the Members' Council and what skills and experience would you use to do this?

Based in Lincolnshire, I would add value to the Members' Council by bringing my knowledge of the co-operative sector and relevant professional experience and skills from my career within local government. For example, of representing the views and concerns of my organisation and members of the public to others, of managing the delivery of services and reacting to customer feedback, receiving financial and other information from other organisations and constructively challenging where necessary, and of ensuring good governance through making sure my organisation operates properly by meeting legal and other requirements and ethical standards. 1. What do you regard as the most important priority for Co-op in 2025?

We are at a tipping point for the global environment at the same time as world events are stressing our economy and food security. For the Co-op to live up to its values and principles, it

must prioritise protecting its ethical and sustainable practices as it copes with these many problems. It would be easy to cut corners and rely on greenwashing, but the Co-op's strength is its reputation as the shop on the high street that will do right by member-owners, the wider public and the wider world. That has to be there to underpin everything else that the business does, especially when the International Year of Co-operatives provides a welcome chance to highlight the many benefits of co-operation around the world and how the Co-op has been such a key part of this. With co-operation between co-operatives, we have an additional means of support that will help us through these difficult times, as long as we nurture it.

#### 2. How do you demonstrate a commitment to Co-op Values and Principles?

The Co-operative Values and Principles align closely with my world view. I have spent my career working for not-for-profit and charity organisations, and also volunteering for community groups outside of my work as I particularly believe that social responsibility, self-help and solidarity are the key to healthy and happy communities.

I currently run a community garden in Nottingham, which I helped to become the first Garden of Sanctuary in the city, supporting refugees. It also works to support those with physical and mental health issues and to provide a friendly community for the socially isolated.

In my home village, I helped found a community organisation based on self-help, that picks and redistributes surplus fruit in the local area and has grown to also run mending workshops, community meals, skill-shares and up-cycling.

## 3. How will you add value to the Members' Council and what skills and experience would you use to do this?

Having been on the Members' Council since 2018, I've gained valuable insights into the workings of the Co-op and the complexities of the business. During that time, I feel my main value to the Council has come from serving on the Sustainable Ethical Leadership Committee. I have a good underpinning of knowledge in this area - beginning with an eco-geography degree and an MSc in Resource Planning, I have worked for nearly 4 decades in various environmentally related roles, both professionally and voluntarily. My main work has been in environmental education in schools and the community, and

I've served on the boards of a number of environmental organisations at a national and local level.

And as a frequent shopper in my local Co-op, I am able to reflect the concerns of other environmentally minded Co-op Members. I'm also able to pass on relevant ideas, research and critiques from a range of environmental groups that I have links to, which have provided a lot of useful insights.

I would welcome the chance to continue to support the Co-op in ensuring its values are at the heart of all it does.
