

Green Britain Group's Tax Strategy Statement

Introduction

The purpose of this document is to outline Green Britain Group's tax policies and strategies for managing tax affairs and mitigating associated risks. This document needs to be published because the Green Britain Group exceeded the relevant thresholds in the year ended 30 April 2025. This document, approved by Green Britain Group's Board of Directors on 30 April 2025, aligns with HMRC's guidance. This policy will undergo annual review with any amendments subject to approval by the Board of Directors.

Tax planning and tax risk

We are committed to ensuring that our tax practices align with both the letter and the spirit of tax laws. When necessary, we seek external advice to confirm the compliance of our tax positions. While we engage in tax planning to support our commercial activities, we do not seek to structure transactions in ways that are led by tax considerations.

In our interactions with third parties, we do not endorse tax avoidance or aggressive tax planning arrangements. We have put in place all reasonable prevention procedures to mitigate the risk of facilitating tax evasion by any associated persons. These measures are proportionate to the level of risk and are continuously monitored for effectiveness.

Green Britain Group utilises exemptions and allowances in accordance with normal business practices and HMRC guidance.

Tax risk management and governance

Green Britain Group's Board oversees the tax strategy and its governance, with responsibility delegated to the Chief Financial Officer (CFO), who is supported by the Finance Director. Taxation risks and the control framework in place to manage those risks are formally documented in a Tax Risk Register, which is regularly reviewed and shared with the Board.

Green Britain Group has no appetite for tax risk. We are fully committed to complying with our statutory tax obligations and strive to ensure that our tax arrangements reflect our commitment to responsible corporate citizenship, both financially and reputationally.



To support our internal accountants responsible for tax matters, Green Britain Group engages external advisers to provide technical expertise when necessary. This engagement is coordinated by the Finance Director covering operational and compliance matters.

Our approach to dealings with HMRC

We engage with tax authorities in a manner that prioritises openness and honesty, aiming to foster positive, long-term relationships. This involves maintaining regular contact and dialogue to ensure complete transparency regarding our tax liabilities and obligations.

In instances where tax legislation lacks clarity or ambiguity arises we proactively disclose our position and any uncertainties to HMRC. This approach applies to both current and future events and transactions.

We consistently review our business processes to ensure compliance with tax legislation.

We consider that the above statement complies with Green Britain Group's obligation under para 16(2) and para 22, Sch 19 Finance Act 2016.
