

Web - Offer T&Cs

These Offer Terms and Conditions (the “**Offer Terms**”) supplement the Terms located at <https://www.awaytravel.com/terms> governing your use of the Services, as defined in the Terms. To the extent these Offer Terms conflict with the Terms, these Offer Terms will control. Any capitalized terms used, but not defined, in the Offer Terms will have the meaning given to them in the Terms.

Prices: Products will be available at 15%, 30% or 50% off regular retail prices (each, as applicable, the “**Offer**”) as marked on a product-by-product basis. The Offer will be displayed on the Site and will automatically be applied to each item prior to purchase. Sales tax, shipping and handling are not included in the Offer. Any items not marked “Final Sale” are subject to Away’s standard return policy; provided that, if your Product is eligible for a refund, you will receive a refund only for the amount you actually paid for such Product purchased during the Offer Period, less any discounts received from bundling of Products.
