

## SMU ANNOUNCES SUCCESSFUL LOCAL BOND PLACEMENT FOR UF 2 MILLION

**Santiago, Chile. July 10, 2024.**- SMU S.A. (“SMU” or the “Company”) (Santiago Stock Exchange: SMU) announced today the successful placement of bonds in the local Chilean market for a total of UF 2,000,000 (approximately CLP 75 billion or USD 80 million) at an annual interest rate of 4.14%, representing a spread of 124 basis points over benchmark. Demand for the transaction was double the placement amount.

The placement was made using SMU’s Series AS bonds (ticker BCSMU-AS), which have an annual coupon rate of 4.4% and a bullet structure, maturing in 6 years. The proceeds will be used in their entirety to refinance financial liabilities. The transaction was met with strong interest from institutional investors, including pension funds, insurance companies and mutual funds.

SMU’s chief financial officer, Arturo Silva, stated, “We are very pleased with today’s bond placement, especially considering the strong demand from investors. Our refinancing strategy has focused on flattening out the Company’s maturity profile by shifting amortizations from 2024 and 2025 to the period between 2029 and 2039, and today’s transaction is part of that strategy. As a result, this year we have issued bonds totaling UF 4.5 million, all with maturity dates within our target range and with proceeds being used entirely for refinancing, leaving us with a very comfortable maturity schedule going forward.”

SMU’s local credit rating is AA- (stable outlook) with both of its credit rating agencies, Feller-Rate and ICR.

BCI Corredor de Bolsa S.A. and Santander Chile acted as placement agents for the transaction.

Dear Ms. Superintendent:

I have been duly authorized to inform you, in accordance with Article 9 and paragraph two of Article 10 of Law No. 18,045, and General Standard No. 30 issued by the Financial Markets Commission (“CMF”), of the following essential fact relating to SMU S.A. (“SMU” or the “Company”):

Today SMU placed dematerialized bearer bonds in the local Chilean market under Series AS (ticker BCSMU-AS), charged to the bond line that is registered with the Securities Registry of the CMF under number 1,179 (“Series AS Bonds”).

The placement of the Series AS Bonds was for a total amount of UF 2,000,000 at an annual interest rate of 4.14%, with an annual coupon rate of 4.4%, and a maturity date of May 30, 2030.

The proceeds of the Series AS Bonds placement will be used in their entirety to refinance existing financial liabilities, as described in the documents filed for this issuance.
