



SMU ANNOUNCES INTERIM DIVIDEND PAYMENT

Santiago, Chile. August 12, 2024. SMU S.A. ("SMU" or the "Company") (Santiago Stock Exchange: SMU) announced in an Essential Fact (Hecho Esencial) that its Board of Directors approved payment of an interim dividend of CLP 0.86011 per share, for a total of CLP 4,956,990,852. This amount, which is equivalent to 75% of net income for the second quarter of this year, will be charged to retained earnings for the 2024 period.

The dividend will be paid beginning on September 5, 2024, to shareholders of record as of the fifth business day prior to such date.
