



## SMU ANNOUNCES INTERIM DIVIDEND PAYMENT

Santiago, Chile. November 10, 2025. SMU S.A. ("SMU" or the "Company") (Santiago Stock Exchange: SMU) announced in an Essential Fact (Hecho Esencial) that its Board of Directors approved payment of an interim dividend of CLP 4.24417 per share, for a total of CLP 24,460,024,723. This amount, which is equivalent to 75% of net income for the third quarter of this year, will be charged to retained earnings for the 2025 period.

The dividend will be paid beginning on December 2, 2025, to shareholders of record as of the fifth business day prior to such date.
