

SMU ANNOUNCES NEW UNIMARC STORE IN THE MUNICIPALITY OF RECOLETA

Santiago, September 4, 2023.- SMU S.A. ("SMU" or the "Company") (Santiago Stock Exchange: SMU) announced today the opening of a new Unimarc store, located in the municipality of Recoleta, in the Santiago Metro Region of Chile, marking the fifth Unimarc opening in 2023. As such, the Company now has a total of 289 Unimarc stores in operation, and the implementation of its organic growth plan continues on schedule. SMU's strategic plan for 2023-2025 includes a total of 58 new store openings, of which 27 will operate under the Unimarc banner.
