### You might know International warehousing as ZFS International Outbound or the ZFS International Program.

In short, it is a solution designed to enable ZEOS to ship customer orders from the local (i.e. non-German) warehouses in our network.


### What is International warehousing?


In **your current setup**, all customer orders are fulfilled from our three main fulfillment centers in Germany: Mönchengladbach, Lahr and Erfurt.

With International warehousing, you unlock seven additional fulfillment centers across Poland, Italy, France, Spain, Sweden and the Netherlands.

- German fulfillment centers
- Non-German fulfillment centers

#### You will see the difference, and so will your customers

## No more cross-border fees

Save costs on orders that are shipped across the borders.

#### Get returns back online quickly

Reduce time to online from an avg. 8-10 days to 2-5 days in the local market.

## Faster customer delivery

~80% of orders in warehousing countries are delivered within 48 hours.

#### Increase your stock turnover

Sell returns again quickly in the local market. Increase stock turnover and reduce your storage fees.

## Improved inbound flexibility

Increasing available inbound capacities and appointments at our hubs in Germany, Poland, and Italy.

## Optimize your stock distribution

Distribute your stock based on regional customer demand. Increase sales effectiveness and turnover rates.



### Cross-border fees **explained**

A cross-border shipping fee is charged for each outbound item that is **dispatched** from Germany to a market where Germany is not the primary region to fulfill that market.







For example, let's say you currently have not enabled our Swedish fulfillment center. That means you are paying cross-border fees for all customer orders to Denmark, Finland, and Sweden.

Once you've enabled this location, you won't pay cross-border fees, even if a customer order has to be shipped from Germany due to stock availability.



#### Improving customer delivery lead times






### Get closer to your customers

By enabling our fulfillment center in Spain, ~69% of customer orders in this market are delivered within 48 hours.

Compared to ~4% with our German warehousing solution.



"We have launched 22 new markets with Zalando in less than 5 months.

After that we decided we need to be closer to our customers, so we have enabled International warehousing, which allows us to ship from localized fulfillment centers, for example in the Netherlands or Sweden.

Before, the estimated delivery to the Netherlands was 3-5 days. Currently, our Dutch customers are getting their order the next day."

### Boost your conversion rates

In addition, internal data shows that estimated lead-times significantly impact conversion rates.

An internal study conducted in 2022 showed that by lowering the estimated delivery at check-out by just 1 day, cart conversion rates increased by up to 27%.



#### What is required from you

#### VAT Registration

Valid VAT registrations are required for each country where you choose to enable an additional fulfillment center.

2

#### Tax Reporting

Sale of goods must be included in VAT returns filed in each country where a fulfillment center is located, for the goods sold from that country. 3

#### Intrastat Reporting

The reporting of movement of goods from one EU state to another must be presented to the local authorities in Germany, as well as each country where a fulfillment center is enabled.






