- Delay in Time to Online for stock
- Poor end customer experience
- Value Added Service (VAS) cost of relabelling will be applied
- Potential for goods to be <u>returned from quarantine storage</u>
- Goods can be damaged during the process
- Added costs and lost sales time, in addition to return shipping
- Potential lost sales due to stock downtime



1. PACKAGING REQUIREMENTS

Articles which are delivered from partners to Zalando must comply with certain packaging conditions.

Sales Unit must be "**retail ready**", with an individual packaging (polybags, boxes and hangers) suitable for the Sales Unit to be sold

The packed Product must not exceed a **maximum dimension of 355x380x590mm LxWxH** and a **maximum weight of 3kg**.

Any Products not compliant with this requirement will be returned at the Partner's expense.

Polybags

- Clear, transparent (must be possible to scan label inside)
- Completely closed for the article not to fall out.
- BHT (Butylated Hydroxytoluene) free.
- Material must be a minimum of 30 microns standard low density polythene.

Boxes

- Fully closed for the article not to fall out or get dirty.
- If the article packaging carton consists of two or more parts, the partner needs to ensure to stabilize and bind them with **sticky dots or plastic stripes**.

Hangers

- Should have a **polybag around the article + hanger**, the wire has to be left outside to store these articles in hanging garment area
- Garments have to be packed separately in closed polybags so that every article has its own bag. Various articles are not allowed to be packed together in the same polybag

2. LOCATION OF THE ARTICLE LABELING

Labeling information on the article packaging (polybag or box) has to match the labeling information which might be attached to the article itself. We ask you to label the article and the packaging for the following reason: when an article is returned by the customer, it is not mandatory to return the polybags, therefore we need the article to be labeled. This is used to identify the article and repackage it.

The following table illustrates the various options for applying the article description (containing the article number, color code/description, size, EAN/GTIN), for more information on the Article label please read this <u>guide</u>.

4. What must I consider in terms of article packaging?

Packaging is mandatory, we do not accept items that are not packed





An open or damaged article packaging is not acceptable

Problem: Open Polybag and hang tag outside (shown by the orange arrow)

The polybag should cover the whole article




Individual sales units in the consolidated packaging are not acceptable



The polybag should be transparent and clear so that the EAN can be scanned
