

Manly Community Forum – Update from Council – 20 June 2023

Item	Response
Shelly Beach Amenities project	The new Shelly Beach amenities project is progressing to project timelines. The intent is to have these facilities fully complete, commissioned, and operational prior to summer.
Ray Mathieson Picnic Shelter	Staff have advised the chairs and picnic shelter will be installed as per the masterplan. Kandy Tagg will confirm wording for the plaque.

Stormwater Works on the Corso	The site was established on Mon 5 June to replace 30 meters of collapsed clay pipes. Concrete pipes have been delivered and stored on site. Works are progressing well and the timeline is currently on track and expected for completion by 31 August 2023, subject to weather and unforeseen conditions.
Darley Road Traffic	The issue with Darley Road and the surface is being dealt with as part of the restoration process once the works by Ausgrid have been completed, also noting that there is proposed works by Sydney Water in the area potentially coming online by the end of 2023.
Pedestrian Crossing on Darley Road	The pedestrian crossings are slated for repainting when the contractors are back in the area in early July.
Request for site meeting to discuss Darley Road Traffic Management	Rita/Andrew to arrange a site meeting with Council staff to meet residents on site.
	Kelly advised she will provide list of residents wishing to attend. Group advised the streets surrounding Darley Road also need to be considered as part of a traffic management plan. It was noted that speeding continues to be a major issue on Darley Road
	Cathy advised the roundabout at the bottom of Darley Road has heritage significance and the original bollards on the roundabout are falling in to disrepair.
