# THIS IS WHAT CHANGE LOOKS LIKE

**When Sarah's mum died just weeks after a cancer diagnosis, Sarah didn't expect to lose her home as well.**

Sarah and her family were forced to move out of the housing association home they'd shared with her mum. And for the next three years Sarah, her son Ishmael, and later baby CJ, lived in temporary accommodation.

"I tried to keep life as normal as possible," says Sarah, "keeping Ishmael at his old school, still going to work every day. But the impact on him soon became clear - he became nervous and his school work suffered."

When Sarah got in touch with us, she was able to access advice that meant that she and her two children finally found a safe, secure social home.

"If I didn't get any help from you, I probably would have ended up in another temporary accommodation. Then how would I live for the future?"

For families like Sarah's, home really is everything. But right now, 16,330 households are living in temporary accommodation in Scotland. That's the highest number on record. We need change - big change.

**Shandor became disabled after an accident at work. It wasn't long before he could no longer afford the rent on his home – and became homeless.**

He was placed in temporary homeless accommodation. But it wasn't a home – and his son, Billy, was scared to stay there at the weekends.

For months, Shandor lived with the uncertainty of not knowing when he'd find a place of his own again – or somewhere Billy could feel safe.

With advice from us, Shandor was able to find a social home – a comfortable, secure place for him, Billy and their rescue dog, Peach.

But Shandor knows he's not alone. And that to fix the housing emergency, we need change. Real change.

# IT'S TIME TO SAY ENOUGH

We need big change to solve Scotland's housing emergency – and by leaving a gift to Shelter Scotland in your will, you can be part of it. No matter how big or small, leaving a gift in your will can help give families the support they need and give us the strength to define a new era. One in which everyone has a safe and secure place to call home.

If you would like to leave a gift in your will, there are a number of ways you can do it.

## A share of your estate

You may wish to leave Shelter Scotland all or part of what is left of your estate after other gifts and debts have been paid.

This type of gift (known as a residuary bequest) has the advantage that it will not be eroded in value by inflation over the years.

## A cash gift

You may wish to leave us a stated sum of money.

With this kind of gift (known as a pecuniary bequest), it is important to remember that the value of money changes over the years, and you may need to alter your will periodically to keep up with inflation.

## Your home

You can leave your home or a specific property you own. This type of gift can make a huge impact in defending the right to a safe home for thousands of families. For example, a house which sells for £290,000 could help a staggering 10,000 people get advice through our emergency helpline and avoid losing their homes.

## A Deed of Variation to a will you benefit under

You may wish to pass on a gift that you have been left in a will to Shelter Scotland by entering into a Deed of Variation. This alters the original terms of the will under which you benefit and may also make the estate more tax efficient by reducing the amount paid in Inheritance Tax.

## Life assurance

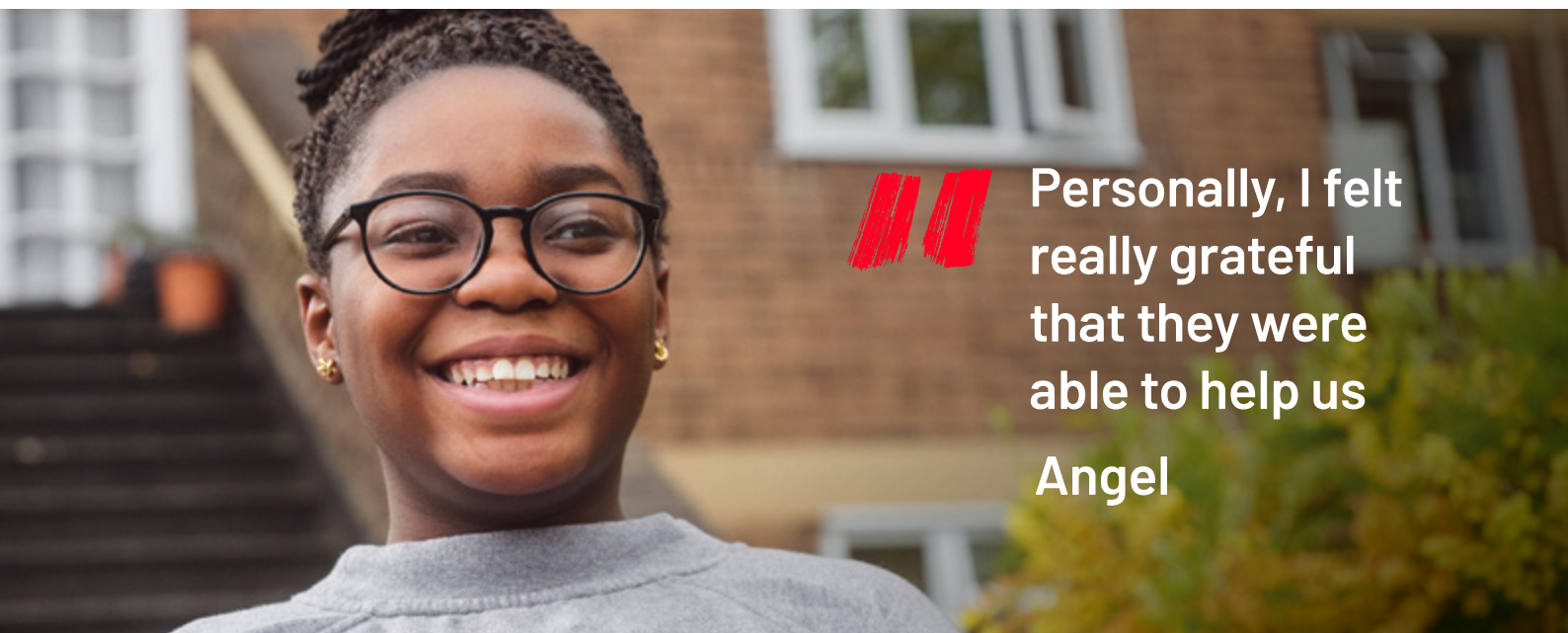
You can name Shelter Scotland as a beneficiary of your life assurance policy. There are no rules for how many beneficiaries you're allowed to include, so including Shelter Scotland is a great way to continue your support for our fight for home.

# WRITE YOUR WILL FOR FREE

If you're interested in writing or updating a simple will, we have partnered with will writing providers so you can do this for free.

**Face-to-face:** use the National Free Wills Network to get your will made using a solicitor in your local area. You can refer yourself online at [mynetworkportal.org/ShelterScotland](https://mynetworkportal.org/ShelterScotland) or email us at [legacies@shelter.org.uk](mailto:legacies@shelter.org.uk) with your address and we'll arrange for an information pack to be sent to you.

**Telephone:** our partner Farewill offer a telephone will service. Speak to a will specialist on the telephone and have your will sent to you by post to sign. Call **0208 050 2686** and quote 'Shelter Scotland' to get started.

## Finding a solicitor

Making or changing your will is simple if you have the right professional help. To find a solicitor, contact the Law Society of Scotland at **[www.lawscot.org.uk/find-a-solicitor](http://www.lawscot.org.uk/find-a-solicitor)** or telephone 0131 226 7411. Before you see your solicitor, you may wish to complete the checklist at the back of this booklet and take it with you to your appointment.

## Inheritance tax

Gifts in your will to registered charities are free of inheritance tax (IHT). So if the value of your estate is more than the tax threshold, a gift to charity could reduce the burden of IHT. Also, if you leave 10% or more of your estate to charity, this can reduce the rate of IHT from 40% to 36% on some assets. ## Keep your will safe

Sadly, wills get lost or mislaid over time. To ensure your wishes are carried out we recommend that you leave the original copy of your will with your solicitor. You can register your will with the National Will Register, for a small fee. See **[www.nationalwillregister.co.uk](http://www.nationalwillregister.co.uk)** for further details.

# Asset checklist

## THREE IMPORTANT STEPS TOWARDS MAKING OR CHANGING YOUR WILL

### 1. Calculate the value of your assets

It is important when you make or change your will to have a clear idea of what your estate is worth. A good way to do this is to list everything you own and its approximate value, based on what you would be likely to receive for each item or asset if you were to sell it now. If you own an item or property jointly with someone else, you should include only the value of your share.

This checklist will help you make a list of what you own and get a good idea of what your estate is worth.

# Making a change to your will

We always recommend that you seek advice from your solicitor when you make or change your will. If you have already made a will and now wish to include a gift to Shelter Scotland, it is often more straightforward to make the addition by asking your solicitor to draw up a new will. Alternatively you can complete a Codicil, an example of which is given below, and take it to your solicitor who can advise you on the best way for your wishes to be carried out.

Shelter Scotland does not recommend that you make a Codicil without consulting a solicitor, who should ensure that any Codicil made is executed correctly and properly reflects your intentions. Please do not write on or amend your current will, as this could make it invalid.
