Here's a list of things you'll have to do if you're going down that route.

| ☐ Obtained legal advice to find out your options? |
| ☐ Obtained a fee quote if a solicitor (or another professional) will be representing you in court? |
| ☐ Found out which sheriff court will deal with your case? |
| ☐ Double-checked the court fees and set money aside to pay for these? |
| ☐ Picked up the correct copy of the summons form including:- |
| Part 1 (the principal summons) and either |
| Part 1a (the copy summons for individuals) or |
| Part 1b (copy summons for companies/other organisations) |
| ☐ Filled in sections 1-7 on the principal summons (or checked they're correct if already filled in) |
| ☐ Inserted the appropriate rate of interest on the summons (or deleted this if appropriate)? |
| ☐ Inserted the date from which interest will run on the principal summons (or deleted this if appropriate)? |
| ☐ Lodged the principal summons with the sheriff clerks' office? |
| ☐ Filled in the correct copy summons (including the return date and hearing date from the principal summons)? |
| ☐ Arranged for the copy summons to be served on your opponent? |
| ☐ Received confirmation of service from the court/post office/sheriff officers as appropriate? |
| \square If you are arranging for service, made sure that the summons has been returned to |
| the court by the return date ? |
| ☐ If service is by newspaper, paid for the advert and lodged a copy of the newspaper with the court? |
| ☐ If service is by a notice in the court building, filled in a form 9 notice as well? |
| ☐ Lodged any other relevant documents or evidence with the court by the appropriate date? |
