## What is social housing?

The Scottish Government defines social housing as:

'Housing owned and managed by public authorities (mainly councils) housing associations, and registered social landlords (RSL)'

## Social housing: a brief history

**1919:** the 'Addison Act' was passed in parliament, paving the way for 500,000 new social rented homes to be built. It is credited with establishing the principle of large – scale, state – funded social rented homes.

**1970's**: social housing reached its height after the post war efforts to rebuild what was lost. Post WW2, the phrase of 'homes fit for heroes' was coined – there were efforts to build good quality housing and provide a higher standard of living in Britain. Scotland had the highest proportion of social housing in Europe.

**1980:** The 'Right to Buy' was passed, giving people living in social rented homes the chance to buy and own their home. Although in principle this was an empowering step forward, in practice it led to the decimation of social housing as there was not enough investment put back into building more social homes. In Scotland, since 1980, more than 500,000 social rented homes have been lost.

- **1999:** The Scottish Parliament is formed, and housing becomes a devolved power.
- **2015**: Shelter Scotland publishes the 'Affordable Housing Need in Scotland' report calling for the next (now current) Scottish

Parliament to commit to building 60,000 new affordable homes (12,000 new homes per year of parliament).


**2016:** The current Scottish Government is formed and pledges to deliver 50,000 new affordable homes, 35,000 of which are for social rent over 5 years. Although this was 10,000 fewer than the recommendation, it was a significant increase from the previous five years which saw the Government commit to delivering 30,000 homes.

**2016:** Right to Buy is abolished in Scotland.

- **2018:** a new report by Shelter Scotland, Scottish Federation of Housing Associations and the Equality And Human Rights Commission estimates that between 45,387 and 49,773 affordable homes are likely to be delivered in the current parliamentary term, 34,850 of which will be affordable homes.
- **2020:** Coronavirus pandemic means that having a safe place to stay home has never been more important.
- **2020:** Shelter Scotland releases new 'Affordable Housing Need in Scotland' report calling for the next Scottish Parliament to commit to building 53,000 new affordable homes, 37,100 should be social rented homes. This is an increase of just 1 new home per day above what the current target is.



## A change in social housing over time



You can see a clear decline in social housing over the years. Scotland may have some of the most progressive housing laws in the world, but there is still much more to be done.



## Key Facts and issues around social housing

### Long waiting lists

There were 131,900 households on local authority housing waiting lists across Scotland, and a further 25,000 on transfer lists as of March 2018

#### Homelessness has been rising since 2010

In 2018- 2019, a household became homeless every 18 minutes. In the same year over 14,000 children. This equates to 38 children becoming homeless every day

#### Too many households in temporary accommodation

On 30 September 2019 there were 11,432 households and 7,252 dependent children in temporary accommodation.

The average time spent by households in temporary accommodation in 2018-19 was 6 months.

### A rise in people living in private rented homes

A Scottish Household Survey revealed that 15% of households now live in the private rented sector. This has more than doubled in just the last ten years.

#### Welfare cuts

Cuts to the Local Housing Allowance has meant a growing gap between private rent levels and what can actually be covered by the allowance.

#### Poor housing conditions

Scottish House Conditions survey revealed that:

1 in ten households in Scotland are affected by damp or condensation

619,000 households live in fuel poverty

And

53,000 households are overcrowded in Scotland. For context, this represents 2% of <u>all</u> households in Scotland.

There is a clear need for genuinely affordable, housing that meets high quality building standards



## Andrew's story

Andrew (38) from Edinburgh has been fighting against Scotland's housing emergency for almost a decade. He's currently living in a private let with his fiancée but he's behind with his rent due to the impact of coronavirus on his work and they are worried that they may lose their home. He's been bidding on social properties in the city for nine years with no success.

"I've been through homelessness before almost 10 years ago and it was horrendous. A previous relationship ended quite amicably. I decided I would take the responsibility of moving out and left my exwife with our social tenancy in 2011...

The first night I was left roaming the streets with everything I owned in a courier bag and two black bin liners. No one told me where to go that night so I ended up sleeping on a bench in the meadows. It was gut-wrenching. Absolutely soul-destroying.

"When I went to the council they sat me in a little room and said we'll assess your 'claim' for homelessness. I was sat there with an eviction notice and nowhere to go and they told me that I had made myself intentionally homeless so the best they could do for me was 60 days in a hostel.

"The hostel had a curfew and I had to be in from 10pm at night to 8am the next day but I had taken on another job with a furniture factory and they had me starting early. **One day the work van**  broke down on the road back from a job in Dundee and by the time I got to the hostel at 10:45pm they'd packed all my belongings into black bags and that was me out that night back to the bench in the Meadows. It was brutal. I was working two jobs but they didn't care."

"The council put me on Edindex and I've been bidding regularly ever since. By now I'll have made hundreds of bids and I take care to go for properties I think other people won't want but I've not come close to an offer of a tenancy.

"I met my fiancée six years ago and we managed to get the deposit together for this place and now we're struggling again due to coronavirus. We're behind two months rent. I've had enough of zero hours contracts. That's all I've had for ten years and it's been killing me. There's no security. It's no way to live."

"If we could get into a social rented house, god, it would just mean security, that's the word – security. We've been in this private rental five years and the landlords have been great but social rented accommodation feels like your own place in the way a private let never would. In a private let you always feel like the landlord can just snap their fingers and change your life completely by making you move. It would be more affordable too."

Andrews' story is just one of thousands of people whose lives would be positively impacted by having access to a social rented home.



## **Build Scotland's Future campaign overview**

#### What is the campaign?

Build Scotland's Future will be a year long campaign that is focussing on getting the next parliament to commit to building more social homes in Scotland

#### What is the commitment to social housing we want?

As outlined in the history of social housing, this year Shelter Scotland released a new affordable housing report. In this report, we have established that the next Government will need to commit to building <u>at least 37,100</u> new social rented homes.

#### How do we get this commitment?

We want all political parties in Scotland to commit to this target in their election manifestos.

#### What is a manifesto?

A manifesto is a publication that will be issued by a political party before an election. It will outline a set of policies and principles that a party will commit to. Manifestos will be published before a UK general election and the Scottish Government elections.

## It's time to build the social homes that Scotland needs

The Scottish Government must commit to building at least 37,100 homes in the next parliament to help to protect people from homelessness, provide hope for people struggling to get by, to secure jobs and reinvigorate our communities across the country.

We're not just talking about bricks and mortar, we're talking about security. We're building safety. We're building stability. We're building a brighter future for our people.

## Get social
